**WHEREAS**, the Section 458 (a)(i)(xi) of the Republic Act No. 7160 otherwise known as the Local Government Code of 1991 provides that the city can provide for additional allowances and other benefits to judges, prosecutors, public elementary and high school teachers, and other national government officials stationed in or assigned to the city;

**WHEREAS**, the dedicated service of police officers is integral in maintaining peace and order within the City of Pasig;

**WHEREAS**, recognizing the exemplary commitment and contributions of retiring police officers is paramount in expressing gratitude for their years of service;

**WHEREAS**, it is deemed fitting to establish an ordinance to formalize the bestowal of a "Pasasalamat Award" as a gesture of appreciation and acknowledgment for the retiring police officers stationed within the City of Pasig;

**NOW, THEREFORE, BE IT ORDAINED**, by the Sangguniang Panlungsod in session duly assembled hereby enacted: **GRANTING SERVICE OF PASASALAMAT AWARD TO THE RETIRING POLICER OFFICERS DETAILED IN THE CITY OF PASIG AND PROVIDING FUNDS THEREOF.**

**SECTION 1: TITLE** - This ordinance shall be known as "Pasasalamat Award Ordinance to the retiring police officers in Pasig City".

**SECTION 2: DECLARATION OF POLICY** - It is hereby proclaimed that the City of Pasig acknowledges and duly recognizes the diligence and service rendered by the police officers currently stationed within the jurisdiction of Pasig City.

**SECTION 3: SCOPE** - This ordinance is applicable to all retired police officers either compulsory or optional in Pasig city who have rendered service for at least ten (10) consecutive years.

AN ORDINANCE GRANTING SERVICE OF PASASALAMAT AWARD TO THE RETIRING POLICE OFFICERS DETAILED IN THE CITY OF PASIG AND PROVIDING FUNDS THEREOF.

**SECTION 4: CASH INCENTIVE PROVISION** - A cash incentive amounting to One Thousand Pesos (₱ 1,000.00) for each year of service shall be conferred upon a police officer who satisfies the following criteria:

- Has been in the active service for at least ten (10) consecutive years.
- Has consistently served for at least ten (10) continuous years within Pasig City.
- Has no pending administrative / criminal complaint filed against him/her in regard to the performance of his/her duties

**SECTION 5: AVAILMENT.** - The immediate supervisor of the qualified police officer shall issue a Certification attesting to the fact that the qualified officer is eligible for the Pasasalamat Award.

The qualified police officer shall secure all the retiring document provided by the Philippine National Police that will establish his/her compliance with the criteria provided in Section 4 of this Ordinance and/or his qualification to the Pasasalamat Award.

**SECTION 6: FUNDING.** - The needed amount to be disbursed in connection with the benefit ordained in this ordinance shall be charged against the Budget of the Office of the City Mayor.


**SECTION 7: EFFECTIVITY PERIOD OF ELIGIBILITY** - This Ordinance shall apply only to police officers retiring from the year 2023 onwards, police officers who retired prior to 2023 shall not be eligible to the benefit of this ordinance ensuring that the "Pasasalamat Awards" shall be granted to those retiring after its enactment.

**SECTION 8: REPEALING CLAUSE.** - Any or all ordinances, rules and regulations, or provisions thereof which are inconsistent or in conflict with the provision of this ordinance are hereby repealed of modified accordingly.

**SECTION 9: EFFECTIVITY CLAUSE.** - This ordinance shall take effect upon approval.
