AN ORDINANCE MANDATING ALL BARANGAYS IN PASIG CITY TO ALLOCATE A SPACE FOR SANGGUNIANG KABATAAN TO BE USED AS SK OFFICES AND FOR OTHER PURPOSES.

WHEREAS, Section 13, Article I of the 1987 Philippine Constitution provides that "the State recognizes the vital role of the youth in nation building and shall promote and protect their physical, moral, spiritual, intellectual, and social well-being, inculcates in them patriotism, nationalism and other desirable values, and encourages their involvement in public and civic affairs";

WHEREAS, it is a declared policy of the State under Section 2 of Republic Act No. 10742, otherwise known as the Sangguniang Kabataan Reform Act of 2015, that the State shall establish adequate, effective, responsive and enabling mechanisms and support systems that will ensure the meaningful participation of the youth in local governance and nation-building;

WHEREAS, in order to ensure that Sangguniang Kabataan officials can perform their duties and responsibilities in their best capacity, it is imperative that they should be provided with the rightful infrastructure and environment;

NOW, THEREFORE, BE IT ORDAINED, BY THE SANGGUNIANG PANLUNGSOD, IN ITS REGULAR SESSION ASSEMBLED, THAT:

SECTION 1. Short title. – This Ordinance shall be known as "an Ordinance for the Establishment of SK Offices in Pasig City."

SECTION 2. Declaration of Policy. – It shall be the policy of the City Government to recognize the vital role of the youth in nation building, and equip them with knowledge and skills to become partners in local governance. Towards this end, the City shall adopt policies that will capacitate and empower the youth, provide them with essential resources, and acknowledge their active and innovative participation in nation-building within their capacity as leaders so that there will be adequate, effective, responsive and enabling mechanisms and support systems that will ensure the meaningful participation of the youth.

SECTION 3. Establishment of Sangguniang Kabataan (SK) Offices. – To carry out the above policy, all barangays are mandated to allocate a space in the barangay hall or in a separate structure within the territorial jurisdiction of the barangay concerned for the exclusive use of SK Officials, and it shall be named SK Office.

SECTION 4. Functions of the SK Office. – The SK Offices shall serve:

1. As the worksite of SK officials who shall have sole discretion on its usage, including, but not limited to, capacity-building training and seminars, the implementation of SK programs, and SK-initiated events and activities;
2. As the main venue for SK Regular and committee sessions; and
3. As a venue for other purposes which may be necessary in the implementation of their programs and projects.

SECTION 5. Repealing Clause. – All ordinances, resolutions, executive issuances, rules and regulations, or parts thereof, whose provisions are inconsistent with or contrary to the provisions of this Ordinance, are hereby deemed repealed, amended, or modified accordingly.

SECTION 6. Separability Clause. – Should any portion or provisions of this ordinance be declared unconstitutional or invalid, the other parts or provisions thereof which are not affected thereby shall continue to be in full force and effect.

SECTION 7. Effectivity. – This Ordinance shall take effect immediately.




