WHEREAS, Section 167 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 provides that all taxes, fees, and charges shall be paid within the first twenty (20) days of January of each subsequent quarter, as the case may be. The Sanggunian concerned may, for a justifiable reason or cause, extend the time for payment of such taxes, fees, or charges without surcharges or penalties, but only for a period not exceeding six (6) months;

WHEREAS, Section 66 of the 2017 Pasig City Revenue Code likewise states that the Sangguniang Panlungsod may, for a justifiable reason or cause, extend the time of payment of such taxes, fees, or charges without surcharges or penalties, but only for a period not exceeding six (6) months;

WHEREAS, the Business Permit and Licensing Department (BPLD) of the City Government of Pasig consistently complies with the abovementioned provision of the law as the deadline for the assessment and payment of the annual business permit renewal;

WHEREAS, in response to the exigencies brought about by the pandemic, requests brought up by the private sector, and based on its own assessment, the BPLD has requested for an extension, without surcharges or penalties, for the assessment and payment of the annual business permit renewal to give ample time to the taxpayer-clients in processing their business renewal permits;

NOW, THEREFORE, THE CITY COUNCIL OF PASIG CITY, IN SESSION DULY ASSEMBLED, resolves, as it is hereby resolved, to extend the deadline for the assessment and payment of CY 2022 Business Permit Renewal from January 20 to January 31, 2022.






