WHEREAS, the City of Pasig maintains its savings and deposits in Pasig Hall, Caruncho Branch of the Land Bank of the Philippines;

WHEREAS, Section 344 of R.A. No. 7160 or otherwise known as the "Local Government Code of 1991" states the following: "*Vouchers and payrolls shall be certified to and approved by the head of the department or office who has administrative control of the fund concerned, as to validity, propriety, and legality of the claim involved. Except in cases of disbursements involving regularly recurring administrative expenses such as payrolls for regular or permanent employees, expenses for light, water, telephone and telegraph services, remittances to government creditor agencies such as GSIS, SSS, LDP, DBP, National Printing Office, Procurement Service of the DBM and others, approval of the disbursement voucher by the local chief executive himself shall be required whenever local funds are disbursed*";

WHEREAS, Section 456(a) (1) of the same code states that the Vice-Mayor shall "*be the presiding officer of the Sangguniang Panlungsod and sign all warrants drawn on the city treasury for all expenditures appropriated for the operation of the Sangguniang Panlungsod*";

WHEREAS, former Vice-Mayor Iyo Christian C. Bernardo was previously authorized to sign checks and other documents drawn for all expenditures of the Sangguniang Panlungsod of Pasig and for other purposes pursuant to the Sangguniang Panlungsod Resolution No 109, Series of 2019, Approved on August 29, 2019;

WHEREAS, the duly elected Vice-Mayor Robert Vincent Jude B. Jaworski Jr. took his oath of office on June 30, 2022;
