WHEREAS, Section 106 of Republic Act No. 7160, otherwise known as the Local Government Code, mandates all local government units (LGUs) to formulate, through their local development councils, comprehensive, multi-sectoral development plans known as Comprehensive Development Plans (CDPs) to set the LGUs' direction of socio-economic development;

WHEREAS, Department of Interior and Local Government (DILG) Memoranda Circular Nos. 2019-172, 2021-037, 2021-049, mandate all LGUs to simultaneously update and enhance their Comprehensive Land Use Plans (CLUPs) and CDPs for uniform periods starting in FY 2021;

WHEREAS, pursuant to said mandate and directive, the expanded Pasig City Development Council (CDC) has, since 2020, been updating the City's existing CDP, which previously covered a time horizon of 2014-2027, and now covers the time horizon of 2022-2027;

WHEREAS, in its Second Meeting held on 17 December 2021, the CDC approved the enhanced and updated CDP for 2022-2027 as well as the Local Development Investment Program for 2022-2024 included therein, which will be the basis for the Annual Investment Programs of the City for the next three (3) years;

WHEREAS, the CDC has transmitted to the Sanggunian Panlungsod copies of the approved CDP for 2022-2027;

WHEREAS, the Local Government Code requires that the CDP be adopted by the Sanggunian Panlungsod through a Resolution;
