WHEREAS, in coordination with the Pasig Urban Settlements Office ("PUSO"), these informal settler families are invoking the provisions of the UDHA and are requesting assistance from the local government;

WHEREAS, to ease the burden of the other members of the community, and to aid them during this time of pandemic, the City Government of Pasig deems it necessary to grant financial assistance to them based on the provisions of the UDHA;

WHEREAS, the landowner Mr. Albano, has generously offered to provide Twenty Thousand Pesos (PhP20,000.00) for each family in recognition of the good governance and the plight of the displaced families;
