WHEREAS, Section 455 (b) (1) (v) of Republic Act 7160 otherwise known as the Local Government Code of 1991 (code) provides that the Local Chief Executive has the power to appoint all officials and employees of the city government.

WHEREAS, pursuant to Section 454 (d) of the same code provides, heads of departments and offices shall be appointed by the City Mayor with the concurrence of the majority of all the Sangguniang Panlungsod members, subject to civil service law, rules and regulations.

NOW, THEREFORE, on motion duly seconded the Sangguniang Panlungsod resolves, as it hereby resolved, to confirm the appointment of Ms. Emma M. Sanchez, as City Government Department Head II of the Department of Veterinary Services, effective July 11, 2022.

RESOLVED, FURTHER, that the budgetary requirement to implement this Resolution shall be chargeable against any available funds in the City Treasury, subject to existing CO rules and regulations.
