WHEREAS, DENR - NCR partnered with the City Government of Pasig in crafting the Climate Resilient and Localized Urban Greening Plan (CRLUGP) for the City of Pasig;

WHEREAS, the CRLUGP is a Geographic Information System (GIS) based plan, which aims to provide a visual tool for LGUs in enhancing their greening and other environment activities;

WHEREAS, CRLUGP contains location of suitable sites for planting of various indigenous forest tree species and fruit-bearing trees in the City of Pasig;

WHEREAS, the adoption of the CRLUGP is a timely initiative for the City of Pasig as a means of strengthening the implementation of NGP and to cut down on its deficit in terms of green space per capita.

MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This MEMORANDUM OF AGREEMENT enter into by and between:

The **DEPARMENT OF ENVIRONMENT AND NATURAL RESOURCES** – **NATIONAL CAPITAL REGION**, with Office address at National Ecology Center, East Avenue, Diliman, Quezon City, herein represented by its Regional Executive Director, **JACQUELINE A. CAANCAN**, *CESO III*, hereinafter referred to as "**DENR-NCR**".

and-

The CITY LOCAL GOVERNMENT OF PASIG with Office address at Caruncho Ave., Barangay San Nicolas, Pasig, 1600 Metro Pasig, herein represented by its City Mayor, VICTOR MA. REGIS N. SOTTO hereinafter referred to as "CITY LGU OF PASIG".

WITNESSETH that:

WHEREAS, Section 16, Article II of the 1987 Constitution provides that the State shall protect and advance the right of the Filipino people to a balanced and healthful ecology in accord with the rhythm and harmony of nature;

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of the Philippines, as amended, mandates every local government unit to promote the general welfare of its constituents by enhancing their right to a balanced ecology and among others;

WHEREAS, Executive Order No. 26, Series of 2011, which declares the National Greening Program (NGP), includes urban areas under the greening plan of Local Government Units (LGUs), as one of the priority sites for planting;

WHEREAS, the Department of Environmental and Natural Resources – National Capital Region (DENR-NCR) is mandated to implement the NGP, in partnership with various stakeholders, including LGUs;

WHEREAS, DENR-NCR partnered with the City Local Government of Pasig in crafting the Climate Resilient and Localized Urban Greening Plan (CRLUGP) for the City of Pasig;

WHEREAS, the CRLUGP is a Geographic Information System (GIS)-based plan, which aims to provide a visual tool for LGUs in enhancing their greening and other environment activities;

WHEREAS, the CRLUGP contains location of suitable sites for planting of various indigenous forest tree species and fruit-bearing trees in the City of Pasig;

WHEREAS, the adoption of the CRLUGP is a timely initiative for the City of Pasig as a means of strengthening the implementation of NGP and to cut down on its deficit in terms of greenspace per capita.

ARTICLE I - SCOPE AND COVERAGE

This Agreement shall cover the all the preparatory activities of the CITY LGU OF **PASIG**, through the assistance of the *DENR-NCR* in relation to the formulation of the Climate Resilient and Localized Urban Greening Plan (CRLUGP) for the City of Pasig.

NOW THEREFORE, for and in confideration of the foregoing premises and of the obligations and undertaking hereinafter setforth, the DENR-NCR and CITY LGU OF PASIG hereby agree that:

ARTICLE II - DUTIES AND RESPONSIBILITIES OF THE PARTIES

A. The DENR-NCR shall:

- 1. Assist the City LGU of Pasig in the preparation of the CRLUGP;
- 2. Provide technical guidance for the City LGU of Pasig in the implementation of the CRLUGP; and
- 3. Provide other technical assistance whenever the circumstance requires.

B. The CITY LGU OF PASIG shall:

- 1. Participate in Focus Group Discussions (FGD) and Key Informant Interviews (KII) in support to the development of the CRLUGP;
- 2. Assist in Greenspace Identification and Mapping;
- 3. Provide assistance in the conduct of on-site visitation and validation;
- 4. Provide necessary data for the holistic preparation of CRLUGP, such as but not limited to,: City Land Use Plan (CLUP), City Development Plan (CDP), ordinances and programs connecting to greenspace management, maps or shapefiles on Disaster Risk Reduction Management (DRRM), Land Use, and Boundary Delineation; and
- 5. Implement the CRLUGP through a city ordinance;

In case of any amendment, modification, or revision of any provision of this Agreement, it shall be done through the mutual consent of the parties concerned.

ARTICLE III - ALTERNATURE DISPUTE RESOLUTION

The parties agree that any conflict, controversies, issues or disputes, which may arise within or during the effectivity of this Agreement shall, in their best efforts, try to settle the same among themselves.

In case of failure to come to an amicable settlement, all disputes between the parties arising from the interpretation or application of this Agreement shall be administratively settled

in the manner provided under Chapter 14, Book IV of Executive Order No. 292, dated July 25, 1987, as amended.

ARTICLE IV - EFFECTIVITY AND TERMINATION

This Agreement shall take effect upon signing thereof by DENR-NCR and CITY LGU OF PASIG, unless terminated by mutual agreement.
