WHEREAS, Section 16, Article II of the 1987 Constitution provides that the State shall protect and advance the right of the Filipino people to a balanced and

healthful ecology in accord with the rhythm and harmony of nature;

WHEREAS, Executive Order (E.O.) No. 26, Series of 2011, ordered and declared the implementation of the National Greening Program (NGP), which is the reforestation program of the Philippines that seeks to plant 1.5 billion trees in 1.5 million hectares, as a government priority, in accordance with the policy of the State to pursue sustainable development for poverty reduction, food security, biodiversity conservation and climate change mitigation and adaptation;

WHEREAS, Sections 2 and 3.2.1 of E.O. No. 26 Series of 2022, provides that all greening efforts of the private sector, local government units (LGUs), and civil society shall be harmonized under the NGP;

WHEREAS, the Department of Environment and Natural Resources (DENR), the lead agency of the NGP, through its regional office, has proposed to support a site within Pasig City to be part of the NGP;

WHEREAS, the Pasig City Government is mandated by Sections 16 and 17 of Republic Act No. 7160, otherwise known as the Local Government Code, to exercise all powers as may be necessary, appropriate, or incidental for its efficient and effective governance, and which are essential to the promotion of the general welfare, including the provision of social welfare and general hygiene and sanitation services;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF PASIG CITY, IN REGULAR SESSION DULY ASSEMBLED, to authorize the City Government of Pasig, through the City Mayor, Victor Ma. Regis N. Sotto, to enter into and sign a Memorandum of Agreement with the Department of Environment and Natural Resources National Capital Region for the adoption and maintenance of a site in Pasig City for three (3) years as part of the National Greening Program;
