

**COMMITTEE REPORT**

The initial hearing on August 8, 2022, at the E-lounge, 7<sup>th</sup> floor Pasig City Hall, with the presence of Councilor Maria Luisa M. De Leon, Councilor Corazon M. Raymundo, Councilor Raymund Francis S. Rustia, Councilor Mark Gil M. Delos Santos, Councilor Roman Santiago, Councilor Syvel Asilo-Gupilan, Councilor Roderick Mario Gonzales, Councilor Regino Balderrama, Councilor Rigor Enriquez, Councilor Georgia Lynne Clemente, Atty. Tosca Mansujeto, and Ms. Marita A. Calaje of Treasury and with the presence of the representatives of concern offices from Treasury office and City Legal Office, Resolution entitled "A Resolution Grating Authority To The City Treasury And/Or The City Legal Office To Enter Into And Sign, For And In Behalf Of The City Government Of Pasig, The Compromise Agreement, With Z-Data Inc. Relative To The Civil Case No. M-Psg-21-02980-Cv Filed by Z-Data Inc. against Hon. Maria A. Calaje, in her capacity as a Treasurer of Pasig.

After a careful study the following resolutions were finalized:


1. As presented by Councilor Marion Rosalio Martires, the Resolution to grant an authority to the City Treasurer and/or the City Legal Office to enter into and sign, for and in behalf of the City Government of Pasig, the compromise agreement, with Z-Data Inc. relative to the civil case no. M-Psg-21-02970-cv filed by Z-Data inc. against Maria A. Calaje, in her capacity as a Treasurer of Pasig.
2. On 2019, the Treasury Office of City of Pasig assessed the Z-Data Inc. in the amount of Four Hundred Six Thousand Four Hundred Forty-Seven Pesos and 60/100 (Php406,447.60). On June 2021, Z-Data Inc. paid the amount of Two Hundred Thirty-Nine Thousand Eighty-Six Pesos and 60/100 (Php239,086.60). After series of negotiations and meetings with Z-Data Inc. re-computation made by the Local Business Tax Department together with the City Treasury Office came up with the amount of Two Hundred Thirty Thousand Five Hundred Nine Pesos and 83/100 (Php230,509.83).
3. The City Treasury Office was able to lower down the amount of refund through tax credit of (Php8,576.77).
4. The City Administrator and the City Mayor approved the recommendation of the City Treasury Office, and now asking the Sanggunian for the authority to sign the agreement.
5. The committee recommends for the adoption of this report and this resolution will be passed on second reading on the next session that will be held on the 11th day of August 2022.








On 19 October 2021, Z-Data, Inc. ("Z-Data") filed a case before the court (now pending before MeTC-Pasig, Branch 154) against Ms. Marita A. Calaje, in her official capacity as City Treasurer of Pasig, for Judicial Protest against Assessment of Local Business Taxes ("LBT") for Calendar Year 2019. Details of the assailed assessment are as follows, to wit:

TAX YEAR	AMOUNT
2019	239,086.60
	- 167,361 (interest and surcharges)
<b>TOTAL</b>	<b>PHP 406,447.60</b> (inclusive of interests and surcharges)

Prior to the filing of the instant case, on 30 June 2021, Z-Data availed of the Tax Amnesty and paid the amount of PhP 239,086.60 under protest.

Z-Data argues that it is not liable for the abovementioned amount of PhP 239,086.60 since a) the basis of the assessment was gross revenue instead of gross sales or receipts conformably with the Local Government Code (LGC).

The instant case is now on its Pre-trial stage. Conformably with the Rules of Court, the case was referred to the Philippine Mediation Center ("PMC") for a possible amicable settlement.

Initially, Z-Data is not amicable to any settlement and would like a total cancellation of the assessment and a corresponding tax refund. Hence, we requested it to submit the necessary supporting documents. Z-Data obliged and submitted several documents, i.e. sales official receipts and LGU certifications regarding it's declared gross sales in its branches (Los Baños, Laguna and Quezon City). Thereafter, we referred the matter to the City Treasurer's Office (CTO) for recomputation, if justified by Z-Data's submissions.

On 11 July 2022, we received CTO's re-computation, details of which are as follows:

TAX YEAR	AMOUNT
2019	230,509.83 <sup>1</sup>

Hence, we communicated the same to Z-Data. During the negotiation, we manifested that the amount reflecting in the recomputation was based on the documents Z-Data submitted and this will be our last recomputation and will no longer consider any other documents/offer.




We respectfully recommend that the City accepts the offer of Z-Data as the same is already fair and reasonable, and beneficial to the City as well.



With your conformity, we will draft a compromise agreement containing proposal on the credit that you recognize. The case will be decided on this basis.




