**A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR VICTOR MA. REGIS N. SOTTO TO GRANT AN ANNUAL ALLOWANCE IN THE AMOUNT OF TEN THOUSAND PESOS (Php 10,000.00) EACH TO ALL SANGGUNIANG KABATAAN CHAIRPERSONS IN THE CITY OF PASIG, EFFECTIVE JULY 2022, AND FOR OTHER PURPOSES.**

**WHEREAS**, Section 423 of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991" and R.A. No. 10742, otherwise known as "Sangguniang Kabataan Reform Act of 2015" recognized the role of Sangguniang Kabataan in providing opportunity for young people to directly participate in local governance;

**WHEREAS**, under Section 430 thereof, Sangguniang Kabataan Chairperson shall automatically serve as an ex officio member of the sangguniang barangay upon his assumption to office. As such, he shall exercise the same powers, discharge the same duties and functions, and enjoy the same privileges as the regular sangguniang barangay members, and shall be the chairman of the committee on youth and sports development in the said sanggunian;

**WHEREAS**, it furtherly stated under Section 431 thereof that an Sangguniang Kabataan Chairperson has the power to call and preside over all meetings of the katipunan ng kabataan and the sangguniang kabataan; implement policies, programs, and projects within his jurisdiction in coordination with the sangguniang barangay; exercise general supervision over the affairs and activities of the sangguniang kabataan and the official conduct of its members, and such other officers of the sangguniang kabataan within his jurisdiction;

**WHEREAS**, in recognition in their vital part in public service, there is a proposal to grant an annual allowance to all Sangguniang Kabataan Chairpersons in all thirty (30) barangays in the City of Pasig;

**WHEREAS**, the Sangguniang Panlungsod finds the above proposal reasonable and meritorious;

**NOW, THEREFORE**, on motion duly seconded, the Sangguniang Panlungsod resolves, as it is hereby resolved, to authorize the grant an annual allowance in the amount of Ten Thousand Pesos (Php 10,000.00) each to all Sangguninang Kabataan Chairpersons in the City of Pasig, effective July 2022 and for other purposes.
