**WHEREAS**, Section 34 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 mandates the local government units to promote the establishment and operation of people's and non-governmental organizations to become active partners in the pursuit of the local autonomy;

**WHEREAS**, Article 64 of the Implementing Rules and Regulation of the Local Government Code of 1991 provides for the procedure and guidelines for the selection of representatives of Civil Society Organizations in the Local Special Bodies;

**WHEREAS**, the Department of Interior and Local Government through its Memorandum Circular No. 2022-083 provides a guidelines for accreditation of civil society organizations and selection of representatives to the local special bodies;

**WHEREAS**, the City Government of Pasig conducted CSO Conference last August 5, 2022 for the purpose of orientation and call for accreditation of different Civil Society Organizations;

**WHEREAS**, item 3.11 of DILG Memorandum Circular defined "Recognized Organization" as an organization allowed by the sanggunian to participate in local special body for purposes of meeting the minimum requirements of membership. An organization may only be recognized if it meets all the criteria except for registration;

**WHEREAS**, the following Civil Society Organizations are hereby recognized by Sanggunian Panlungsod, to wit:
