**WHEREAS**, the Annual Investment Program is included in the Comprehensive Development Plan (CDP) of Pasig City from 2015 to 2023, as augmented by essentials response and recovery programs to address the COVID-19 pandemic and its effects;

**WHEREAS**, the adoption of the Annual Investment Program is essential as it serves as the basis for the funding of development programs, projects, and activities of the City for the 2023 Annual Budget;

**WHEREAS**, after a brief deliberation, the members of this Body decided to approve the Annual Investment Program for CY 2023;

**NOW, THEREFORE**, upon motion duly seconded by all members present, it is **RESOLVED**, as it is hereby **RESOLVED**, to approve the Annual Investment Program of the City Government of Pasig covering the period from January 1, 2023 to December 31, 2023.

**COMMITTEE REPORT**

The initial hearings on August 15, 16, and 17, 2022 at the Session Hall Plenary Hall, 7th floor, Pasig City Hall, with the presence of Councilor Mark Gil Delos Santos, Councilor Maria Luisa De Leon, Councilor Quin Cruz, Councilor Syvel Asilo-Gupilan, Councilor Raymund Francis Rustia, Councilor Corazon M. Raymundo, PhD, Councilor Roderick Mario U. Gonzales, Councilor Regino Balderrama, Engr, Noel Agustin, Councilor Rigor Enriquez, with the presence of SK Fed. Pres. Georgia Lynne Clemente with the Proposed Resolutions adopting Resolution No. 23-2022: A Resolution Approving The Annual Investment Program Of the City Government Of Pasig Covering The Period From January 1, 2023 To December 31, 2023.

After a careful study in each sector, the following resolutions were finalized:

1. As presented by Councilor Marion Rosalio Martires, a Resolution adopting the Resolution No. 23-2022: A Resolution Approving the Annual Investment Program of The City Government of Pasig Covering the Period from January 1, 2023, to December 31, 2023.
2. Under the **Environmental Development Sector**, the following points were finalized:
  - a. The 2023 annual budget amounting to PHP 9.9 billion covers the expenditure of Pasig City Disaster Risk Reduction and Management Office, City Environment Office, and City Waste Management Office.
  - b. The budget breakdown proposed by the Environment Agency is based on the Department of Budget and Management Program Expenditure Classification.
  - c. The following are the issues and concerns to be resolved:
    - I. Increase in hazardous wastes due to PPEs waste;
    - II. Lack of sewerage system;
    - III. Informal settlements along the rivers and creeks;
    - IV. Air pollution problem;
    - V. Lack of green open spaces; and
    - VI. Other environmental hazards.
  - d. The following are the objectives for the city's improvement:
    - I. To achieve and maintain a clean, healthy, and safe ecosystem;
    - II. Decreased vulnerabilities and exposure, and enhanced capacities of communities;
    - III. Establish and strengthen the capacity of communities to anticipate the mentioned problems above;
    - IV. Provide life preservation and meet basic substantial needs;



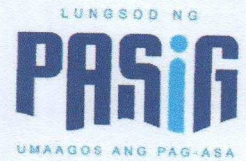

- V. Restore and improve livelihood and living conditions;
  - VI. To improve air quality in the city of Pasig with the help of private sector;
  - VII. Prioritize clean and safe water quality in all rivers and creeks;
  - VIII. Maintenance and improvement of RAVE through hiring of consultants such as gardeners; and
  - IX. Biodiversity and urban greening programs such as the Pasig Biodiversity Program and Capacity Building Biodiversity Program.
- e. The budget utilization for this year is in the 50% margin according to the estimation of the Local Finance Committee. The estimation of budget utilization involves the City Environment and Natural Resources Offices for their local personnel and major allocation to their personal services.
- f. The Sangguniang Panlungsod proposed to the Environment department to pay attention with their programs since there are delays despite them having major allocations to the personal services' improvement.
- g. The Environment agency suggested that for the programs to put in place, comparative analysis between the government sector and the private sector shall be the elementary requirement. The following are the steps suggested in the committee session to avoid failure in waste management:
- I. Establish a contract with a private institution for waste management;
  - II. Admin waste management must prioritize system involving the improvement of trucks and monitoring personnel for grassroots collection;
  - III. Program for smokers such as the regulations for the smoking areas in public buildings and private areas as suggested by Councilor Mark Gil M. Delos Santos;
  - IV. Allot more budget to WACS for the efficiency of solid waste collection; and
  - V. Contingency program for capacity building of personal services since the environment sector produced ineffective technical personnel.
- h. According to Environmental Management Sector, Pasig City follows DENR's policies – recently, they had training for anti-smoke belching operation. In addition, they have plans to further improve programs for the personal services, management system, the pollution control officers, technical people, and policies towards the issue of used oils.
3. Under the **Economic Development Sector**, the following points were discussed:
- a. The Economic Sector provided discussion revolving on the major determinants of Pasig's economy such as the number of business enterprises, economic level of families and individuals, utilization of Pasig's assets (i.e., tourist spots, business programs, and historical products and sites), the fast tracking of business registration, and the process of finding strategic business sites.
  - b. The issues concerning the decline in business registration and uneven distribution of business enterprise are one of the issues and concerns of the Economic Sector.



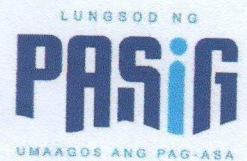

With the mentioned issues in place, the Economic Sector thought of a plan prioritizing the increase of investment opportunities for business enterprise - specifically, the Micro, Small, and Medium Enterprises (MSMEs).

- c. The poverty rate inside Pasig is in the 21% mark which equates to 100,006 Pasigueños with net income around 12,000 pesos. With the help of the Public Employment Service Office (PESO) and the Department of Labor and Employment (DOLE), the Economic Sector of Pasig came up with short-term and long-term plans to solve the rising economic instability in Pasig. The following are the steps to its improvement:

- I. Implementation and adaptation of DOLE's policies;
- II. Marketing of historical sites and products;
- III. Incorporation of barangay business consultation to the process of providing business opportunities;
- IV. Utilization of market space through Tulong at Pampuhunang Ayuda sa Taga-Pasig (TAPAT) program;
- V. Completion of tourist and development plans with the first phase accomplished and the second phase on-going;
- VI. Application of cultural mapping, economic mapping, sector-based and barangay-based location of strategic business opportunities;
- VII. Beautification of markets;
- VIII. Prioritization of revenue generating assets;
- IX. Proper regulation;
- X. To market tourism sector; and
- XI. Economic enterprise development.

4. Under the **Social Development Sector**, these are finalized:

- a. The Social Sector shares the largest percentage in terms of cost at 71% of the total funding requirement compared to other sectors. They are in charge of Pasig's health, housing, education, protective services, social welfare services, and sports and recreation programs.
- b. In the 100% total budget utilization target, 45.23% of the budget were already utilized. The utilization target by this month was supposedly at 50% mark. The Commission on Audit (COA) deduced that Pasig's Social Sector has a low utilization percentage. The Social Sector attributed this low mark to the transitional phase of the Pasig administration.

c. **Health Sector**

- I. The City Health Department utilized 25% of its appropriations in the first two quarters for medical supplies. However, it was argued that the utilization was quite low as it was supposed to be over 50% in the first two quarters. Thus, the procurement process is the problem. The following are the reasons of the delays:

1. Deliberation process of public funds



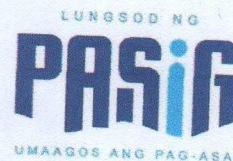

2. Contract: High demands/strict requirements
3. Government policies that are more of restraints than opportunities
4. Competition of suppliers to undergo deliberation and post qualification – the need to comply to Pasig and COA's requirements
5. Supply-chain management (shortage of health center personnel); and
6. Unavailability of medicine is attributed to the problem on the procurement process

II. In relation to the problems mentioned above, these points were reiterated and the Social Development Sector appropriated part of the budget for the following:

1. Prioritization of Universal healthcare – development objectives for the betterment of facilities, supplies, and expansion, performance of significant personnel, and fast-tracking of requirements, renovations of healthcare centers and hospitals
2. They also mentioned that they will be getting special health funds from the World Bank and LGU

III. The committee also recommended to relate their planning to the population, demography, and ecological profile of the residents.

**d. Housing**

- I. The comprehensive development plan will cover five years of projects. With the AIP of 2023, the direction of the housing sector's plan will target 18,665 informal settlers, 1,646 creek informal settlers, and 4,303 families that will be relocated to Moltalban, Tanay, Southville and any parts of relocation sites in Rizal. To emphasize, Southville is a success according to the Housing Sector as they achieved 70% access to water from 0%. But, the electricity is a problem since only 30% of the constituents were given access.
- II. According to the Housing Sector, relocation project centers are the priority, neither the housing nor expansion. But a few housing projects will be provided. The Housing Sector reiterated that they must follow the National Housing Authority (NHA) and the Department of Public Works and Highways' policies.
- III. The utilization of the Housing Sector's budget will be directed to the on-site and off-site location of constituents - housing within and outside Pasig. 300 units to Tanay and 1,000 units to Morong Bataan as per NHA. The budget last 2021 was not utilized which is still yet to be utilized in today's year. The Housing Sector prioritized buying house lots for housing projects. In addition, to ensure the safety of the constituents within the relocation sites, they create security forces which will be coordinated with Tanay executives to have a technical working rule.



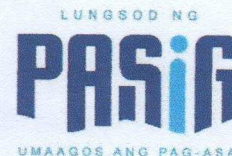

**e. Education**

- I. The budget allotted to the PCSHS, PLP, and Special Education Institution was included in the 48.5% of the education sector's budget that has already been utilized for sustaining and operating costs. The PCSIT and Pasig City Library have 0% utilization yet 34.1% and 19.5% are earmarked, respectively.
- II. A part of the budget will be set aside for capacity development and seminars to produce skilled and competent personnel and to upskill them so that they can be eligible for promotion.
- III. Due to the procurement problems, the PCSIT developed a scarcity of consumable supplies. In Special Education Institution, the number of teachers is not proportionate to the number of students. While the PLP has a Php 67,000,000 supplemental budget for infrastructure in connection with their plan to implement hybrid learning next academic year
- IV. There is also an appropriated budget for the reconstruction of the Pasig City Library. On top of that, the LGU and DOST have already approved the proposed design for the construction of Modern Library in the year 2024.
- V. The target number of beneficiaries for the Pasig City Scholars this year is 23,000 beneficiaries. However, the City Mayor aims to have a progressive number of scholars. In addition, the number of employees that work under the Pasig City Scholar is small compared to the expected number of scholars.

**f. Social Welfare Services**

- I. Utilization to the general fund covers Bahay Kalinga, MOOE, Bahay Kanlungan, and budget for the City Social Welfare and Development Office (CSWDO). The CSWDO provided that the Bahay Kanlungan need psychologists to monitor the constituents' well-being including moms, children, elderly, and children in conflict with law (CICL). In addition, as a temporary solution to the struggle in management, workers in the personal services work hand-in-hand with the 'three work-shift' system.
- II. The CSWDO presented a comprehensive program on street children. This includes educational assistance to those who are registered to the ALS program and financial assistance through community service or livelihood jobs. They were also eyeing an alternative target, "Balik-probinsya program".
- III. The CSWDO argued that the inefficiencies are caused by the screening process and intervention of other cities. Most of the rescued target subjects are coming from other cities, only 29% of the street dwellers are from Pasig. Thus, interventions of other cities regarding the management of Pasig hinder operations.
- IV. The AYUDA programs last year will be appropriated to the Alay Pasasalamat program. As an alternative to AYUDA, the CSWDO will also conduct livelihood training, marriage counseling, and seminars for solo



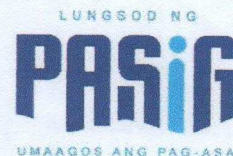

parents. On the other hand, education and scholarship programs are for kids. All of these will be a proactive and reactive approach. By and large, the Sangguniang Panlungsod figured out that the assessment for application and availability of personnel are a problem. There were suggestions to expand help desks. However, it takes a long process to provide the supposed benefits of the constituents.

**g. Youth Development**

- I. The Local Youth Development Office has already utilized 47% of their budget. In connection with that, the Local Youth Development Office reiterated that they have continuous plans for the youth development programs that focuses on education, economic empowerment, and environment.
- II. Part of their budget was allocated for the mandatory and continuous trainings and seminars for newly elected SK Officials. In addition, there is also an appropriated budget for the youth programs, school youth development, and youth movement. They are also organizing a Youth Wellness Plan, however, the budget for this program will be coming from the City Health Department.
- III. The committee, however, spotted a few shortcomings in the proposed annual program of the Youth Development Sector. The committee laid down issues concerning youth and how the LYDO can address the mentioned problems. Issues in reproductive health, addiction, suicide, cybercrime, and pornography were listed.
- IV. To address the issue in addiction, the LYDO reiterated that in terms of Sports and Recreation, there is an allocated budget for inter-barangay events amounting to Php1,182,000. For youth individuals who are not capable of participating in physical sports, there is also an appropriated budget for E-Sports

**h. Office of the Senior Citizen**

- I. The Office of the Senior Citizen Affairs (OSCA) plans to utilize the Gender and Development (GAD) budget and their own continuing budget appropriation.
- II. There is no major allocation to the construction of OSCA's office. The 2023 investment plans distributed 0% to personal services. The Social Sector argued that they should not be allocating to infrastructure and prioritize shortage of personnel. However, councilor Quin A. Cruz suggested that strategizing the location of offices can contribute to the efficiency of bureaucratic processes - this means that infrastructure must also be a priority along with personal services.
- III. Accreditation process of Civil Society Organizations (CSOs) and the proposed plan for the retired teachers to be placed as barangay coordinators to help with the effective management of senior citizens' associations will



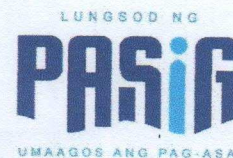

also be noted. In regards to access to benefits, Councilor Quin suggested that senior citizens must have access to benefits regardless of the association they belong to as long as they could prove that they are senior citizens.

**i. Peace and Order**

- I. The Bantay Pasig, Public Safety Division, Kabataan Rescue Patrol, Action Line Division, and Admin Division as the mandated lead agencies were tasked to manage peace and order withing Pasig City. Seventy-nine million seven hundred twenty-eight thousand one hundred eighty-seven pesos (PHP 79,728,187) will be allocated to the said lead agencies.
- II. The budget utilization will primarily focus on alleviating the internal negligence of the peace and order department from the past year. The direction of the budget utilization shall address the following:
  1. Rescue operations;
  2. Joint operations;
  3. Illegal settlers from or outside Pasig City;
  4. Maintenance of stable peace and order in government facilities and schools; and
  5. Prioritization of Bantay Pasig and other peace and order agencies.
- III. Enhancement of personal services, significant personnel training, capacity development with 35.2% budget allocation, accounting for the highest budget allocation among program components. The peace and order sector also allocated a budget for radio, cars, internet connection, and other equipment necessary for the peace and order officials. Maintenance and Other Operating Expenses (MOOE) is the least prioritized based on the budget appropriations authorized by the Department of Budget and Management. On top of that, the government was urged to shoulder the budget to training equipment and access to training of technical personnel.
- IV. The Sangguniang Panlungsod urged the Peace and Order Sector to address the salient features related to peace and order and be mindful with the scope and limitation of their administration as there were issues prompted during the session regarding demolitions outside their jurisdiction.

5. Under the **Institutional Sector**, the following were reiterated:

- a. The institutional sector emphasized that the objective of their department is to provide a transparent government and accountable delivery of service. With that, they intend to strengthen the governance structure and the capabilities of all local government personnel.
- b. As an institution they will give attention to the rationalization of the Pasig City Relations Office, which includes Ugnayan ng Pasig, PIO, and DRRM.



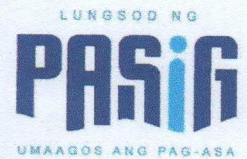

- c. In addition, the Institutional sector will prioritize and allocate a budget for the response to the Covid-19 pandemic aside from the partnerships with the NGOs and PNP.
  - d. This sector elucidated the programs that will be conducted for the next few years.
    - I. One of which is the Pasig Smart City Digital Transformation Program, which aims to accelerate the utilization of information technology and management information systems across processes and offices in the delivery of public services, financial management, and administrative operations. The estimated total cost for this project is Seven Hundred Ninety-One Million Three Hundred Fifty Thousand Pesos (Php 791,350,000.00) and will be from the LGU funds. The Pasig City bureaucracy, private sector, and civil society organizations as clients, public service stakeholders of the city are the target beneficiaries of this project.
    - II. The source of funds for the programs that will be mentioned will be from their own-source revenues. These programs are as follows: Land Use Development, Revenue Sourcing and Generation, Quality Management Program, External Audit Program, Effective Service Delivery Program, Human Resource Development Program, Capacity Development Program of Local Finance Offices, and Human Resource Management Program.
6. Under the **Infrastructure Development Sector**, the following points were finalized:
- a. The objective of this sector is to provide safe, inclusive, affordable, accessible, and sustainable transport for all Pasigueños. They will provide an active transport development like redesigning of sidewalks, safer pedestrians, installation of blinking lights, update traffic lights and signages, repair and maintain the sidewalks and bike lanes, and enhance provision of essential facilities and utilities that support social, economic, environmental, and institutional services. Aside from those mentioned above, their top priority is to improve their performance in road safety and to maintain their operational state to provide safe and updated transport for all.
  - b. They will allocate a budget for the PUV modernization and Route Rationalization program that focuses on the intermodal facilities. Furthermore, they will conduct consultations, seminars, trainings, and workshops to acquire the necessary knowledge and skills for the planned hiring of additional personnel.
  - c. The infrastructure sector will also allocate a budget for the procurement of medical supplies, fuel, oil, lubricants, office supplies, and other maintenance and operating expenses to enhance the Tricycle Operation Services.
  - d. They will also appropriate budget for the Project KONEK Tubig to provide safe and accessible water for all Pasigueños. Additionally, they plan to integrate the existing policies on utility expansion such as inspections, permissions, fines, and penalties for the program Oplan Kaayusan.
  - e. They will also carry out a master plan for drainage improvement, monitoring, and evaluation that includes drainage surveys, mapping, assessment, and detailed



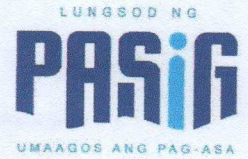




design. On top of that, there is also an allotted budget for the dredging of various creeks or barangays. In connection with that, the infrastructure sector reiterated that they are planning to make Pasig City a Sponge City.


- f. There is also an appropriated budget for the reconstruction, rehabilitation, and renovation of various buildings, including comfort rooms, etc. One of their top priorities is the Pasig Mega Market, Tanghalang Pasigueños, and Pasig City Museum.
  - g. The CTDMO already utilized 19.1% of their budget and earmarked 19.6% of their appropriations. While the engineering office already utilized 17.7% of their budget and earmarked 30% of their appropriations.
7. This committee approved this report, recommends for its adoption and this resolution be passed on second reading, next session that will be held on the 11th day of August 2022.




