WHEREAS, the forty-four (44) poor and underprivileged families, residing at 747 Compound, F. Soriano St., Brgy. Sto. Tomas, Pasig City ("Subject Property"), respondents in an ejectment proceeding, wherein the court ordered, with finality, that they should vacate the Subject Property.

WHEREAS, the said displaced forty-four (44) families have been duly validated by the Pasig Urban Settlements Office (PUSO) as poor and underprivileged, as defined by the National Economic and Development Authority (NEDA);

WHEREAS, these forty-four (44) displaced families are requesting for financial assistance from the Local Government of Pasig City.

WHEREAS, to ease the burden of the forty-four (44) displaced families, being members of the community, and to aid them during this time of pandemic, the City Government of Pasig deems it necessary to grant financial assistance to them in this time of need;

WHEREAS, the City Government of Pasig shall provide financial assistance in the amount of Seven Thousand Pesos (Php 7,000.00) for each of the thirty-nine (39) affected families below:
