WHEREAS, DILG Memorandum Circular No. 2019-143 mandates every Local Peace and Order Council to formulate a three (3)-year Peace and Order and Public Safety Plan and recommend strategic actions or activities in promoting, improving or enhancing peace and order and public safety measures;

WHEREAS, the promotion of peace and harmony is a shared responsibility between the national and local governments, and while there are national government instrumentalities tasked to address criminality and other forms of lawlessness, local authorities are equally responsible for maintaining peace and order in their communities as provided for under the general welfare clause of RA 7160;

WHEREAS, the Pasig City Peace and Order Council has approved the Pasig City Peace and Order and Public Safety (POPS) Plan for 2023-2025, which was formulated after series of orientation, inter-agency meetings, and workshops;

WHEREAS, the POPS Plan contains the list of programs, projects and activities (PPAs) for implementation to address existing issues on peace and order arising in Pasig City;

NOW, THEREFORE, upon motion duly seconded, the Sangguniang Panlungsod of Pasig, in session duly assembled, **RESOLVES**, as it hereby **RESOLVES, TO ADOPT THE PASIG CITY PEACE AND ORDER AND PUBLIC SAFETY (POPS) PLAN FOR 2023-2025.**

RESOLVED, FURTHERMORE, that the Secretary of the Sangguniang Panlungsod furnish all concerned agencies and/or offices with copies of this Resolution, as duly, adopted and approved by the Sangguniang Panlungsod.

RESOLVED, FINALLY, that the copy of the POPS Plan 2023 – 2025 shall form integral part of this Resolution.
