WHEREAS, Section 455 (b) (1) (V) of Republic Act 7160 otherwise known as the Local Government Code of 1991 ("Code") provides that the Local Chief Executive has the power to appoint all officials and employees of the city government;

WHEREAS, pursuant to Section 454 (d) of the same code provides, heads of departments and offices shall be appointed by the city mayor with the concurrence of the majority of all the Sangguniang Panlungsod members, subject to civil service law, rules and regulations;

WHEREAS, Ms. Juvy A. Cuenco applied for the position of the City Government Department Head II of the Accounting Office of the City Government of Pasig, and have undergone the regular process through the Human Resource Development Office, subsequently approved her appointment by the City Mayor as appointing authority on January 3, 2023;

NOW, THEREFORE, on motion duly seconded the Sangguniang Panlungsod resolves, as it hereby resolved, to confirm the appointment of Ms. Juvy A. Cuenco, as City Government Department Head II of the Accounting Office of the City Government of Pasig, effective January 3, 2023.

RESOLVED, FINALLY, that the Secretary of the Sangguniang Panlungsod furnish all concerned agencies and/or offices with copies of this Resolution, as duly, adopted and approved by the Sangguniang Panlungsod.
