WHEREAS, Republic Act No. 6975 otherwise known as the Department of Interior and Local Government Act of 1991 and its Implementing Rules and Regulations mandate the creation of People's Law Enforcement Board (PLEB) in every city;

WHEREAS, the PLEB shall have jurisdiction to hear and decide citizen's complaints or cases filed before it against erring officers and members of the Philippine National Police;

WHEREAS, Section 43 (b) (1) of same Act states that the PLEB shall have a member from the Sangguniang Panlungsod chosen by their respective Sanggunian;

WHEREAS, after deliberation, the Sangguniang Panlungsod of Pasig City, has chosen Honorable Councilor Mark Gil M. Delos Santos as its representative to the PLEB as provided by law;

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod, hereby designates Councilor Mark Gil M. Delos Santos, as representative of Sangguniang Panlungsod of Pasig City to the People's Law Enforcement Board.
