A RESOLUTION AUTHORIZING THE CITY GOVERNMENT OF PASIG THROUGH THE HONORABLE CITY MAYOR, VICTOR MA. REGIS N. SOTTO, TO ENTER INTO AND SIGN A MEMORANDUM OF UNDERSTANDING WITH THE UNIVERSAL ROBINA CORPORATION, AND FOR OTHER PURPOSES.

WHEREAS, the GREENWALL PROJECT was conceived in response to the City's aim for a better environment despite the lack of open spaces, with the aim of having the green walls aid in improving air quality in various areas of the City;

WHEREAS, among the green walls established is the Bagong Ilog Green Wall, situated along the Pasig-Makati Boundary, C5 Road, Brgy. Bagong Ilog, Pasig City;

WHEREAS, Universal Robina Corporation (URC) is supportive of the City's programs on environmental management, and is committed to jointly holding activities that promote environmental conservation as seen in its Tree Planting Activity at Kapasigan Linear Park, Brgy. Kapasigan, Pasig City held on 25 June 2022 by URC employees and personnel from the City Parks and Playground Development Office;

WHEREAS, URC has expressed its interest in adopting the Bagong Ilog Green Wall to ensure the continuity and sustainability of the same, especially as it is located near URC's Pasig plant facility;

WHEREAS, City Government of Pasig welcomes community participation in the implementation and maintenance of its projects;

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of hereby resolves, as it hereby resolved to authorize the City Government of Pasig through Honorable City Mayor, Victor Ma. Regis N. Sotto, to enter into and sign a Memorandum of Understanding with the Universal Robina Corporation.

RESOLVED, FURTHERMORE, that the Secretary of the Sanggunian Panlungsod furnish all concerned agencies/offices copies of this Resolution, as duly adopted/approved by the Sanggunian Panlungsod.
