WHEREAS, the Department of Public Works and Highways (DPWH) is mandated to undertake the implementation of the Pasig Marikina River Channel Improvement Project ("Project") to be financially assisted by the Japan International Cooperation Agency through the Special Terms for Economic Partnership Loan Programme;

WHEREAS, the main objective of the said Project is to mitigate flood damages to Metro Manila caused by the channel overflow of the Pasig-Marikina River, thereby facilitating urban development and enhancing sustainable environment along the river;
