A RESOLUTION AUTHORIZING THE CITY GOVERNMENT OF PASIG THROUGH THE HONORABLE CITY MAYOR, VICTOR MA. REGIS N. SOTTO, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE SPORTS COMMISSION, AND FOR OTHER PURPOSES.

WHEREAS, the Philippine Sport Commission (PSC), by virtue of R.A. No. 6847, also known as the Philippine Sports Commission Act, encourages wide participation of all sectors, government and private, in amateur sports promotion and development, and provides incentives, recognitions and awards to deserving associations, athletes, referees, game officials, coaches, trainers and other persons or entities involved in or supporting sports development as may be permissible under the rules of amateurism;

WHEREAS, Executive Order No. 44, series of 1998 created the Philippine Youth Games - Batang Pinoy (Batang Pinoy), as an integral part of the national policy and program for sports development which will effectively address the country's need for a comprehensive grassroots sports program centered on values formation inherent in the practice of sports and play such as patriotism, nationalism, self-discipline, respect for law and order, hard work, teamwork, camaraderie, sportsmanship, and fair play; thus eliminating the child's chances of becoming a juvenile delinquent;

WHEREAS, the PSC, in partnership with the Provincial Government of Ilocos Sur, hosted and organized the Batang Pinoy National Championships 2022 held in the City of Vigan, Province of Ilocos Sur from December 17-21, 2022;

WHEREAS, the PSC grants incentives to the top 5 local government units (LGUs) in the Batang Pinoy National Championships 2022 based on the over-all official medal tally to be used for the LGU's grassroots sports promotion and development and talent identification programs;

WHEREAS, the City of Pasig participated in the Batang Pinoy National Championships 2022 and won 2nd place in the over-all official medal tally;

WHEREAS, the PSC will grant the City of Pasig the total amount of Two Million and Five Hundred Thousand Pesos (Php 2,500,000.00) as cash incentive for winning 2nd place in the over-all official medal tally during the Batang Pinoy National Championships 2022;

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod hereby resolves, as it hereby resolved, to authorize the City Government of Pasig through the Honorable City Mayor, Victor Ma. Regis N. Sotto, to enter into and sign a Memorandum of Agreement with the Philippine Sport Commission.
