SOTTO, TO GRANT FINANCIAL ASSISTANCE TO NINE (9) REGIONAL TRIAL COURT PASIG CITY MEMBERS OF THE PHILIPPINE WOMEN JUDGES ASSOCIATION IN THE AMOUNT OF SEVENTY-SIX THOUSAND FIVE HUNDRED PESOS (PHP 76,500.00), WHERE EACH AND EVERY JUDGE SHALL RECEIVE THE AMOUNT OF EIGHT THOUSAND FIVE HUNDRED PESOS (PHP 8,500.00), TO DEFRAY THE COST OF THEIR PARTICIPATION IN THE 28<sup>TH</sup> ANNUAL CONVENTION/SEMINAR TO BE HELD ON MARCH 20 TO 22, 2023 AT CONRAD HOTEL, PASAY CITY, AND FOR OTHER PURPOSES.

**WHEREAS**, on March 20 to 22, 2023, the Philippine Women Judges Association will be having its 28<sup>th</sup> Annual Convention/Seminar at Conrad Hotel, Pasay City;

**WHEREAS**, the theme for the convention: "Kamusta ka? The Mental Well-Being of Women Judges as a Key to Efficiency and Resilience" is timely and relevant after more than two (2) years of pandemic;

**WHEREAS**, the nine (9) judges of the Regional Trial Court of Pasig City who will be attending the said convention/seminar sought for financial assistance from the City Government of Pasig for their participation in the said convention/seminar;

**WHEREAS**, the City Government of Pasig acknowledges the indispensable role of the Judiciary, and deems it meritorious to hereby grant financial assistance to them in the amount of Eight Thousand Five Hundred Pesos (Php 8,500.00) each to help defray the cost of their participation in the said convention/seminar;

**NOW, THEREFORE**, on session duly assembled, the Sangguniang Panlungsod, resolves, as it is hereby resolved, to authorize the City Mayor, Honorable Victor Ma. Regis N. Sotto, to grant financial assistance to nine (9) Regional Trial Court Pasig City members of the Philippine Women Judges Association in the amount of Seventy-Six Thousand Five Hundred Pesos (Php 76,500.00), where each and every judge shall receive the amount of Eight Thousand Five Hundred Pesos (Php 8,500.00), to help defray the cost of their participation in the 28<sup>th</sup> Annual Convention/Seminar to be held on March 20 to 22, 2023 at Conrad Hotel, Pasay City.

**RESOLVED, FURTHERMORE**, that the budgetary requirement to implement this Resolution shall be chargeable against any available funds in the City Treasury, subject to existing COA rules and regulations.
