**WHEREAS**, the Philippine Women Judges Association (PWJA) will be holding a seminar/convention at the Conrad Hotel, Pasay City on March 20 to 22, 2023, with "Mental Well-Being of Women Judges" as its central theme;

**WHEREAS**, judges of the Metropolitan Trial Court of Pasig City who will be attending the said seminar/convention sought for financial assistance from the City Government of Pasig for their participation in the said event;

**WHEREAS**, the City Government of Pasig acknowledges the indispensable role of judges in their administration of justice, and deems it meritorious to hereby grant financial assistance in the amount of Eight Thousand Pesos (Php 8,000.00) to each Metropolitan Trial Court Judge to help defray the cost of their registration in the said convention;

**NOW, THEREFORE**, on session duly assembled, the Sangguniang Panlungsod, resolves, as it is hereby resolved, to authorize the Honorable City Mayor Victor Ma. Regis N. **RESOLVED, FURTHERMORE**, that the budgetary requirement to implement this Resolution shall be chargeable against any available funds in the City Treasury, subject to existing COA rules and regulations.

**RESOLVED, FINALLY**, that the Secretary of the Sangguniang Panlungsod shall furnish all concerned agencies/offices copies of this Resolution, as duly adopted/approved by the Sangguniang Panlungsod.
