A RESOLUTION AUTHORIZING THE CITY GOVERNMENT OF PASIG, THROUGH THE HONORABLE CITY MAYOR, VICTOR MA. REGIS N. SOTTO, TO ENTER INTO AND SIGN A MEMORANDUM OF UNDERSTANDING WITH THE NATIONAL CENTER FOR MENTAL HEALTH FOR THE UPSKILLING OF THE CITY'S HEALTH CARE PROVIDERS IN MANAGING INDIVIDUALS IN NEED OF MENTAL HEALTH AND PSYCHOSOCIAL SUPPORT, AND FOR OTHER PURPOSES.

WHEREAS, the National Center for Mental Health is a Special Training and Teaching Hospital, mandated to provide a comprehensive range of quality mental health services nationwide and, under Republic Act No. 11036, otherwise known as The Mental Health Act, to expand its capacity for research and development of interventions in mental, neurological, and psychosocial services in the country;

WHEREAS, as a member of the Response Cluster (National Level) of the Department of Health (DOH), the National Center for Mental Health has several roles and responsibilities including training and capacity building;

WHEREAS, the National Center for Mental Health through its Center for Wellness under the Special Concerns Unit, provides Mental Health and Psychosocial Support (MHPSS) Training, which aims to provide capacitation through overview of existing interventions universally accepted and used/evaluated by the DOH, MHPSS practitioners, and partners during emergencies;

WHEREAS, the National Center for Mental Health intends to promote cooperation to educate and capacitate its personnel to strengthen the knowledge, skills, and capabilities in responding to emergencies;

WHEREAS, the City Government of Pasig has a local Disaster Risk Reduction and Management Office that is responsible for setting the direction, development, implementation and coordination of disaster risk management programs within Pasig City, including the deployment of local emergency response and rapid assessment teams;

WHEREAS, the National Center for Mental Health recognizes the competencies of the city government, through its leaders and members, in performing its role to continuously improve the region's emergency response system;

WHEREAS, the National Center for Mental Health has manifested its intent to partner with the city government in the provision of services to its personnel and service-users;



RESOLVED, FURTHERMORE, that the copy of the said Memorandum of Understanding shall form an integral part of this Resolution.


