**A RESOLUTION AUTHORIZING THE CITY GOVERNMENT OF PASIG THROUGH THE HONORABLE CITY MAYOR, VICTOR MA. REGIS N. SOTTO, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF TRANSPORTATION (DOTr), AND FOR OTHER PURPOSES.**

**WHEREAS**, Republic Act No. 8749 otherwise known as the Philippine Clean Air Act of 1999, makes it a policy of the State to maintain a quality of air that protects human health and welfare;

**WHEREAS**, Executive Order No. 125-A, Series of 1987 mandated the Department of Transportation (DOTr) as the primary policy, planning, programming, coordinating, implementing, regulating and administrative entity of the Executive branch of the government in the promotion, development and regulation of dependable and coordinated networks of transportation systems as well as in the fast, safe, efficient and reliable, transportation services;

**WHEREAS**, under the same Executive Order, the DOTr is empowered to call upon any agency, corporation or organization, whether public or private, whose development and programs include transportation as integral parts hereto, to participate and assist in the preparation and implementation of a comprehensive and integrated programs for transportation;

**WHEREAS**, pursuant to its mandate, DOTr launched the Public Utility Vehicle (PUV) Modernization Program, a long-term solution of the national government to the worsening condition of the transportation sector. It also promotes improvement of air quality by deploying eco-friendly mobility services;

**WHEREAS**, to further realize the preceding objectives, the DOTr has partnered with the United Nations Development Programme (UNDP) to initiate the execution of the Promotion of Low Carbon Urban Transport System in the Philippines (LCT) Project, funded under the Global Environmental Facility, with the aim of promoting sustainable transportation system in the Philippines by creating enabling environments for motorized and non-motorized low carbon transport options;

**WHEREAS**, the DOTr and UNDP have selected Pasig City as a pilot site for the LCT Project, and the City Government of Pasig has expressed its willingness to support the same especially as it is in the process of preparing its Transportation Development Plan;
