A RESOLUTION AUTHORIZING THE CITY GOVERNMENT OF PASIG THROUGH THE HONORABLE CITY MAYOR, VICTOR MA. REGIS N. SOTTO, TO ENTER INTO AND SIGN A MULTI - YEAR CONTRACT ON PRIMARY HEALTHCARE INFORMATION AND CLINICAL SYSTEM WITH THE DBP DATA CENTER INC., AND FOR OTHER PURPOSES.

WHEREAS, in pursuit of excellence in the deliverance of public service and further advancement of the general welfare of the residents of the city, the City Government of Pasig, in its path to achieving Universal Healthcare Coverage (UHC), is currently in search of a service provider which can fully deliver a Primary Healthcare Information and Clinical System for the subsequent use of its ten (10) Philhealth Konsulta Accredited Health Facilities and thirty-five (35) Barangay Health Centers of Pasig City;

WHEREAS, in order to successfully implement this project, the City Government of Pasig needs a service provider engaged in the IT industry and expert in exponential advances;

WHEREAS, DBP Data Center Inc., (DCI) a government owned and controlled corporation, with primary mandate to provide information and technology facilities management, systems application development, systems integration, providing IT solutions, contact center operations, business processes outsourcing, consulting services, and other IT related services to government and private institutions;

WHEREAS, DCI is capable of providing a Primary Healthcare Information and Clinical System (PHICS) designed to conform to the normal operation of any government Primary Care Clinic or Health Centers;

WHEREAS, DCI has the necessary tools, proven experience, expertise, equipment, manpower and resources to implement and effectuate the said project;

WHEREAS, the DCI has offered its services to implement the said project and the City Government of Pasig has accepted to use and utilize the services of the former for a two (2) year period Multi-Year Contract for the efficient and effective delivery of quality and innovative services to its constituency;

WHEREAS, Section 53 of the Implementing Rules and Regulation of R.A. 9184 also known as the Government Procurement Reform Act, particular to Section 53.5 thereof, states that a Procuring Entity may resort to Negotiated Procurement in cases of Agency-to-Agency engagement;






