**WHEREAS**, Republic Act No. 7160 otherwise known as the Local Government Code of 1991, mandates the strengthening of effective mechanisms for ensuring the accountability of local government units to their respective constituents in order that the quality of local leadership may continuously be upgraded.

**WHEREAS**, the Action for Economic Reforms (AER) is a civil society policy, advocacy and action think tank working on key issues on fiscal reforms, health measures, industrial policy, and freedom of information has embarked on a 24-month project, Data-Driven Development in the Philippines (PH3D) in partnership with the European Union;

**WHEREAS**, the Right to Know Right Now (R2KRN) Coalition is a broad network of advocates from the academe, labor sector, the youth, civil society organizations, and media campaigning for the passage of the Freedom of Information (FOI) law and the promotion FOI practice in the country;

**WHEREAS**, PH3D project intended to improve governance, performance and transparency of the City Government of Pasig by enhancing the capacity of Civil Society Organizations to enable an environment conducive for data-driven participatory decision making;

**WHEREAS**, AER, R2KRN and City Government of Pasig would like to sustain the gains of the project by entering into a Memorandum of Understanding;

**NOW, THEREFORE**, on motion duly seconded, the Sangguniang Panlungsod of hereby resolves, as it hereby resolved to authorize the City Government of Pasig through Honorable City Mayor, Victor Ma. Regis N. Sotto, to enter into and sign a Memorandum of Understanding with the Action for Economic Reforms and Right to Know Right Now.

**RESOLVED, FURTHERMORE**, that the Secretary of the Sanggunian Panlungsod furnish all concerned agencies/offices copies of this Resolution, as duly adopted/approved by the Sanggunian Panlungsod.
