WHEREAS, the Philippine Judges Association sought for financial assistance from the city government in relation to the said interpersonal gathering of the members of the judiciary;

WHEREAS, the City Government of Pasig acknowledges the indispensable role of the judiciary in administration of justice, and deems it meritorious to hereby grant financial assistance to the Philippine Judges Association to help defray the cost of their interpersonal gathering;

NOW, THEREFORE, on session duly assembled, the Sangguniang Panlungsod resolves, as it is hereby resolved, to authorize the Honorable City Mayor, Victor Ma. Regis N. Sotto, to grant financial assistance in the amount of One Hundred Sixty Thousand Pesos (Php 160,000.00) to the Philippine Judges Association for their Interpersonal Gathering with a theme "Service Driven Judiciary" on March 24, 2023.
