WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare within their respective territorial jurisdictions, and shall promote full employment among their residents;

WHEREAS, Section 455 (b) (1) (vi) of the same Code, provides that the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance;

WHEREAS, the Local Government Unit (LGU) seeks to improve the well-being of its people, ensure their economic security, and provide employment opportunities;

WHEREAS, the Pasig City Public Employment Service Office (PESO), maintained by the LGU, is tasked with the development of livelihood and employment programs for its constituents;

WHEREAS, Lalamove Philippines, Inc. is a company that provides delivery and courier services by connecting its users with Partner-Drivers on its mobile and web apps;

WHEREAS, the PESO shall assist the LGU in the implementation of the Lalamove - Pasig City PESO Project which aims to accept verified Partner-Drivers to provide private carrier services to the users of Lalamove;


WHEREAS, in order to provide employment opportunities to its constituents, the LGU deems it necessary to enter into a partnership with Lalamove Philippines, Inc.;


