A RESOLUTION ADOPTING THE PASIG CITY COUNCIL FOR THE PROTECTION OF CHILDREN (PCCPC) RESOLUTION NO. 2, SERIES OF 2022, ENTITLED: "A RESOLUTION APPROVING AND ADOPTING THE 2023 ANNUAL INVESTMENT PROGRAM OF PASIG CITY AND THE FUNDS APPROPRIATED IN THE 2023 ANNUAL BUDGET OF PASIG CITY FOR THE ONE PERCENT (1%) SHARE OF THE LCPC IN THE CITY'S INTERNAL REVENUE ALLOTMENT (IRA)", AND FOR OTHER PURPOSES.

WHEREAS, Section 15 of Republic Act No. 9344 otherwise known as the "Juvenile Justice and Welfare Act of 2006" does not only mandate local government units to establish their Local Council for the Protection of Children (LCPC) at the city level but also authorizes the allocation of one percent (1%) of their Internal Revenue Allotment (IRA) for the strengthening and implementation of the PPAs of the city's LCPC;

WHEREAS, the City Government of Pasig is committed to uphold and protect the rights of children and shall encourage and support programs to ensure the survival, development, protection and participation of children in governance and in ensuring transparency and informed participation in budgeting for children's PPAs;

WHEREAS, the Pasig City Council for the Protection of Children (PCCPC) passed and approved Council Resolution No. 2, Series of 2022, approving and adopting the child-focused programs, projects and activities in the 2023 Annual Investment Program (AIP) and 2023 Annual Budget of the City, representing the one percent (1%) share in the City's IRA for 2023 as the LCPC's Annual Work & Financial Plan for 2023;

NOW, THEREFORE, BE IT RESOLVED BY THE SANGGUNIANG PANLUNGSOD, IN REGULAR SESSION DULY ASSEMBLED, to adopt the PCCPC Resolution No. 2, Series of 2022, entitled "A Resolution Approving and Adopting the 2023 Annual Investment of Program of Pasig City and the Funds appropriated in the 2023 Annual Budget of Pasig City for the one percent (1%) share of the LCPC in the City's Internal Revenue Allotment".

RESOLVED, FINALLY, that the Secretary of the Sangguniang Panlungsod furnish all concerned agencies/offices copies of this Resolution, as duly adopted/approved by the Sangguniang Panlungsod.
