WHEREAS, Metro Manila and surrounding areas are traversed by the active Valley Fault System and affected by other major fault systems in Luzon Island which also puts the region at severe risks from earthquakes;

WHEREAS, Republic Act 10121 or the Philippine Disaster Risk Reduction and Management Act of 2010, provides for the development of policies and plans and the implementation of actions and measures pertaining to all aspects of disaster risk reduction and management, including good governance, risk assessment and early warning, knowledge building and awareness raising, reducing underlying risk factors, and preparedness for effective response and early recovery;

WHEREAS, RA 10121 mandates the City Development Councils to ensure the integration of disaster risk reduction and climate change adaption into local development plans, programs and budgets as a strategy in sustainable development and poverty reduction;

WHEREAS, CRS is implementing SHAKE Project Phase 2 (Supporting Households and LGUs Awareness and Knowledge for Earthquake Preparedness) and Preparing for Enhanced Protection in Disaster (PrEPD) through the financial support of the United States Agency for International Development-Bureau for Humanitarian Affairs (USAID-BHA), which aims to strengthen the resilience of 5 City/Municipal Local Government Units and 10 barangays in Metro Manila and Bulacan Province to better withstand the impacts of earthquakes, its secondary hazards and other disasters and ensuring safe and dignified programming;

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod resolves, as it is hereby resolved, to authorize the City Mayor, Honorable Victor Ma. Regis N. Sotto, to enter into and sign a Memorandum of Understanding with the Diocese of Pasig, Caritas Pasig, Inc. and Catholic Relief Services - United States Conference of Catholic Bishops, for supporting households and LGU's awareness and knowledge for Earthquake Preparedness Project - Phase 2.
