A RESOLUTION ADOPTING THE LOCAL CULTURAL INVENTORY OF THE CITY OF PASIG, ENDORSING THE LOCAL CULTURAL INVENTORY TO THE NATIONAL COMMISSION FOR CULTURE AND THE ARTS, AND FOR OTHER PURPOSES.

WHEREAS, Article XIV, Section 14 of the 1987 Philippine Constitution provides that the State shall foster the preservation, enrichment, and dynamic evolution of a Filipino national culture based on the principle of unity in diversity in a climate of free artistic and intellectual expression;

WHEREAS, Sections 14 and 16 of Republic Act No. 10066, otherwise known as the National Cultural Heritage Act of 2009, mandate local government units through their cultural offices, to maintain an inventory of cultural property and monitor the various cultural property under its jurisdiction. Further, local government units are directed to document traditional and contemporary arts and crafts, including their processes and makers, and sustain the sources of their raw materials;

WHEREAS, the local inventory shall be submitted to the National Commission for Culture and Arts ("NCCA") for inclusion in the Philippine Registry of Cultural Property ("PRECUP");

WHEREAS, Joint Memorandum Circular No. 2021-001 issued by the Department of Interior and Local Government and the NCCA, provides a standardized guideline for local government units in their preparation of local cultural inventory and its subsequent submission to the PRECUP;

WHEREAS, in compliance with its mandate, the City Government of Pasig in coordination with the NCCA conducted and implemented the first Cultural Mapping Project, which yielded initial information on 51 significant cultural properties consisting of 23 intangible cultural heritage, 17 intangible immovable, 8 tangible movable, and 3 cultural properties, within the City of Pasig. The outcome of the first Cultural Mapping Project was validated by the Pasig City Council for Culture and the Arts;

WHEREAS, in Resolution No. 1, Series of 2023, dated 6 March 2023, the Pasig City Council for Culture and the Arts endorsed the local cultural inventory of the City of Pasig to the Sangguniang Panlungsod for appropriate action and consideration;




