**WHEREAS**, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare within their respective territorial jurisdictions, and shall promote full employment among their residents;

**WHEREAS**, Section 455 (b) (1) (vi) of the same Code, provides that the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance;

**WHEREAS**, as a response to the Coronavirus Disease 19 (COVID-19) global pandemic, the entire island of Luzon was placed under an Enhanced Community Quarantine (ECQ) which contributed to the job displacement as well as massive unemployment among the constituents of the City of Pasig;

**WHEREAS**, the Local Government Unit (LGU) of Pasig aims to provide job opportunities to its people through developing partnership agreements with the private sector, and in turn, restore its economy;

**WHEREAS**, Sarisuki Stores, Inc. is a community selling platform that provides internet-enabled grocery and food delivery services in the Philippines;

**WHEREAS**, the Pasig City Public Employment Service Office (PESO) shall assist the LGU in the implementation of the NCR – Sarisuki Self-Employment Livelihood Partnership (the “Project”);

**WHEREAS**, the Project shall recruit two hundred fifty (250) TODA members and displaced workers as Partner-Agents to use the Sarisuki application for business;






