A RESOLUTION RECOGNIZING THE EXEMPLARY PERFORMANCE OF PASIGUEÑOS IN PROFESSIONAL LICENSURE EXAMINATIONS GIVEN BY THE PROFESSIONAL REGULATORY COMMISSION AND THE PHILIPPINE BAR EXAMINATION, AND FOR OTHER PURPOSES.

WHEREAS, Section 2 of Republic Act No. 8981, otherwise known as the "PRC Modernization Act of 2000" provides that the State recognizes the important role of professionals in nation-building and, towards this end, promotes the sustained development of a reservoir of professionals whose competence has been determined by honest and credible licensure examinations and whose standards of professional service and practice are internationally recognized and considered world-class brought about by regulatory measures, programs and activities that foster professional growth and advancement;

WHEREAS, the same law authorizes the Philippine Regulatory Commission ("PRC") to regulate and supervise the practice of professionals who constitute the highly skilled manpower of the country in various fields;

WHEREAS, the City Government of Pasig recognizes the important role of its constituents in nation-building and that the professionals among them constitute a significant manpower that can propel various developmental needs in local industries;

WHEREAS, the PRC conducts licensure examinations for various professions to accredit or authorize the successful examinees to the practice of their respective profession or occupation;

WHEREAS, the City Government of Pasig would like to recognize the exemplary performance of its constituents who passed their respective board examinations especially those who finished at the Top 10 positions;

WHEREAS, for purposes of this Resolution, the following regulated professions listed by the PRC are covered: Agriculture, Architecture, Accountancy, Professional Teaching (Education). Engineering, Dentistry, Medicine, Chemistry, Nursing, Medical Technology, Criminology, and other regulated professions not within the PRC mandate such as Law;

WHEREAS, in recognition of this academic achievement, the City Government of Pasig shall: (i) give cash incentives to the successful passers in the following amounts:

- Top 1 - One Hundred Thousand Pesos (Php 100,000.00);
- Top 2 - Eighty Thousand Pesos (Php 80,000.00);
- Top 3 - Sixty Thousand Pesos (Php 60,000.00);
- Top 4 to 5 - Fifty Thousand Pesos (Php 50,000.00);
- Top 6 to 10 - Thirty Thousand Pesos (Php 30,000.00);

(ii) provide a Certificate of Recognition designed for the purpose; and (iii) post an announcement of such feat on tarpaulins posted in conspicuous places within the City;

WHEREAS, the City Government of Pasig shall diligently conduct a verification of the results of licensure examinations based on reports of the concerned licensing boards in various media, and if need be, through an actual inquiry from the licensing board;

WHEREAS, the Sangguniang Panlungsod shares the joy and pride of the successful examinees and their families and unanimously would like to represent the Pasig constituents in honoring our achievers;

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod resolves, as it is hereby resolved, to recognize the exemplary performance of Pasigueños in professional licensure examinations given by the Professional Regulatory Commission, and the Philippine Bar Examination.


