WHEREAS, Republic Act No. 11291 or the Magna Carta of the Poor, declares that it is a policy of the State to uplift the standard of living and quality of life of the poor and provide them with sustained opportunities for growth and development;

WHEREAS, the Department of Social Welfare and Development established the National Household Targeting System for Poverty Reduction ("NHTS-PR") or the *Listahanan Talaan ng Pamilyang Nangangailangan* ("Listahanan") an information management system to identify and target the poorest households in the country so that they can be given assistance through various social welfare programs;

WHEREAS, Executive Order No. 867 directed all National Government Agencies (NGAs) to adopt the results of NHTS-PR in identifying prospective beneficiaries of social protection programs nationwide, and since then, the Listahanan has been a reliable basis for determining potential beneficiaries of around 1,200 social protection stakeholders consisting of NGAs, local government units (LGUs), and civil society organizations (CSOs) that implement social protection programs and services;

WHEREAS, Section 16 of Republic Act No. 7160 empowers local government units to exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of social welfare services;

WHEREAS, the City Government of Pasig advocates for evidence-based program planning and intends to use the Listahanan database for the effective delivery and implementation of wide range anti-poverty programs and basic services within the city;

NOW, THEREFORE, on a motion duly seconded, the Sangguniang Panlungsod resolves, as it is hereby resolved, to authorize the Honorable City Mayor, Victor Ma Regis N. Sotto, to enter into and sign a Data Sharing Agreement with the Department of Social Welfare and Development to grant the City Government of Pasig secured access to the Listahanan data maintained by the DSWD.



RESOLVED FURTHER, that copies of the Data Sharing Agreement shall form an integral part of this Resolution;


