WHEREAS, Davies Paints Philippines Inc., ("Davies") is the top paint exporter and distributor of one of the best premium decorative paint brands in the Philippines and has set up its first manufacturing plant and office in Pasig City;

WHEREAS, Davies offered to re-paint selected public places such as bridges, pedestrian overpasses, flyovers, center islands, intersections, and perimeter walls within the territorial jurisdiction of the City of Pasig in aid of the City's development plan;

WHEREAS, the City Government of Pasig recognizes the need to establish partnership and cooperation between the city government and private sector for the effective implementation of its development plans;

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod resolves, as it is hereby resolved, to authorize the Honorable City Mayor Victor Ma. Regis N. Sotto, to enter into and sign a Memorandum of Agreement with Davies Paints Philippines Inc., for the repainting of selected public spaces in Pasig City.
