WHEREAS, the First Level Clerks of Court Association of the Philippines (FLECCAP) will be holding its National Convention and Seminar and Election of Officers (Convention) on November 22-24, 2023, at the La Carmela de Boracay, Malay, Aklan, Philippines;

WHEREAS, the theme for the Convention, "Kamusta ka? The Mental Well-Being of Women Judges as a Key to Efficiency and Resilience" is relevant and well-timed after more than two years of pandemic;

WHEREAS, the six (6) members of FLECCAP for Pasig City who will be attending the said convention and seminar sought for financial assistance from the City Government of Pasig for their participation in the said Convention;

WHEREAS, the City Government acknowledges the indispensable role of the Judiciary, and deems it meritorious to hereby grant financial assistance to FLECCAP in order to help defray the cost of their participation in the said Convention;






