A RESOLUTION ADOPTING THE PASIG CITY DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL RESOLUTION NO. 6, SERIES OF 2023 ENTITLED: "A RESOLUTION AUTHORIZING THE GRANT OF FINANCIAL ASSISTANCE IN THE AMOUNT OF ONE MILLION PESOS (PHP 1,000,000.00) EACH FOR THE PROVINCES OF ILOCOS NORTE, ILOCOS SUR, CAGAYAN, PAMPANGA, BULACAN, BATAAN AND ABRA EXCLUSIVELY FOR THE VICTIMS OF THE SOUTHWEST MONSOON AND TROPICAL CYCLONE EGAY. THE FINANCIAL ASSISTANCE SHALL BE GRANTED TO AFORESAID PROVINCES TO ALLEVIATE THE DEVASTATING EFFECTS OF THIS NATURAL CALAMITY TO THE LIVES AND LIVING CONDITIONS OF THEIR RESPECTIVE CONSTITUENTS PARTICULARLY TO THOSE WHO ARE SITUATED IN THE SEVERELY AFFECTED AREAS", AND FOR OTHER PURPOSES.

WHEREAS, Rule 18, Sections 1 and 2 of the Implementing Rules and Regulations of Republic Act No. 10121, otherwise known as the Disaster Risk Reduction and Management Act of 2010, mandated Local Government Units to set aside not less than five percent (5%) of the estimated revenue from regular resources for Local Disaster Risk Reduction Management Fund (LDRRMF), otherwise known as the Calamity Fund;

WHEREAS, Section 21 of Republic Act No. 10121, states that "Upon the recommendation of Local Disaster Risk Reduction and Management Office (LDRRMO) and the approval of Sanggunian Panlungsod concerned, the Local Disaster Risk Reduction Management Council (LDRRMC) may transfer the said fund to support disaster risk reduction work of other LDRRMCs which are declared under the state of calamity";

WHEREAS, the Pasig City Disaster Risk Reduction and Management Office (PCDRRMO) recommends to the Pasig City Disaster Risk Reduction Management Council (PCDRRMC) through its Chairman, Honorable City Mayor Victor Ma. Regis N. Sotto, to extend financial assistance using the Pasig City Disaster Risk Reduction and Management Fund (PCDRRMF)-Special Trust Fund to the most affected provinces;

WHEREAS, the financial assistance shall provide temporary respite to those affected provinces in time of great distress while in the process of relief and rehabilitation;

WHEREAS, the PCDRRMC, through its Resolution No. 6, Series of 2023, authorized the grant of financial assistance in the amount of One Million Pesos (Php 1,000,000.00) each for the following provinces: Ilocos Norte, Ilocos Sur, Cagayan, Pampanga, Bulacan, Bataan, and Abra;
