A RESOLUTION ADOPTING THE PASIG CITY DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL RESOLUTION NO. 5, SERIES OF 2023 ENTITLED: "A RESOLUTION APPROVING THE DONATION OF FORTY (40) UNITS OF HANDHELD RADIO AND NINE (9) UNITS OF DIGITAL FIXED BASE RADIO TO BUREAU OF FIRE PROTECTION (BFP) AND ONE HUNDRED EIGHTY (180) UNITS OF HANDHELD RADIO AND TEN (10) UNITS OF DIGITAL FIXED BASE TO PHILIPPINE NATIONAL POLICE (PNP)-PASIG", AND FOR OTHER PURPOSES.

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates local government units to promote and preserve the welfare, safety and interest of their inhabitants;

WHEREAS, the City Government of Pasig values the constituents of this City thus, provision of communication support will ensure their safety and welfare;

WHEREAS, the City Government of Pasig through the Pasig City Disaster Risk Reduction and Management Office (DRRMO) procured and issued forty (40) units of handheld radio and nine (9) units of digital fixed base radio to BFP and one hundred eighty (180) units of handheld radio and ten (10) units of digital fixed base radio to PNP-PASIG;

WHEREAS, the Pasig City Disaster Risk Reduction and Management council, in its Resolution No. 5, series of 2023 approved the donation of the said equipment to the BFP and PNP-PASIG;

WHEREAS, a deed of donation will be given to BFP and PNP-PASIG beneficiaries to transfer the ownership, encumbrances, and dues of the said handheld radios and digital fixed base radio;

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod resolves, as it is hereby resolved, to adopt the Pasig City Disaster Risk Reduction and Management Council Resolution No. 5, Series of 2023 entitled: "A RESOLUTION APPROVING THE DONATION OF FORTY (40) UNITS OF HANDHELD RADIO AND NINE (9) UNITS OF DIGITAL FIXED BASE RADIO TO BUREAU OF FIRE PROTECTION (BFP) AND ONE HUNDRED EIGHTY (180) UNITS OF HANDHELD RADIO AND TEN (10) UNITS OF DIGITAL FIXED BASE TO PHILIPPINE NATIONAL POLICE (PNP)-PASIG."
