A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, VICTOR MA REGIS N. SOTTO, TO ENTER INTO AND SIGN A MEMORANDUM OF UNDERSTANDING WITH FUTRAN PHILIPPINES INC., TO CONDUCT A FEASIBILITY STUDY IN CONSIDERATION OF A POSSIBLE "PEOPLE MOVER PROJECT OR MASS TRANSIT SYSTEM" PROJECT (INVOLVING MONORAIL, LIGHT RAIL, AND/OR PERSONAL RAPID TRANSIT) THAT UTILIZES A "GREEN CONCEPT" IN THE CITY OF PASIG, AND FOR OTHER PURPOSES.

WHEREAS, in accordance with Section 16 of the Local Government Code, the Sangguniang Panlungsod is empowered to prioritize the general welfare, which includes safeguarding the safety, comfort, and convenience of its inhabitants;

WHEREAS, the City has witnessed a notable surge in economic growth, leading to an increase in population, workforce, and tourism, consequently contributing to the issue of traffic congestion;

WHEREAS, the Sanggunian acknowledges the pressing need to address this traffic congestion problem and believes that the implementation of a mass transit system could offer a viable solution;

WHEREAS, Futran Philippines Inc., a company specializing in transportation and public utility services, particularly in developing sustainable and renewable energy-based expressways and train systems, is willing to extend its technical expertise to aid in resolving the traffic congestion issue;

WHEREAS, Futran Philippines Inc., proposes to conduct a feasibility study for the possible establishment of a "People Mover Project or Mass Transit System" (Utilizing Monorail, Light Rail, and/or Personal Rapid Transit) that utilizes a "green concept" in the City of Pasig;

WHEREAS, the Sanggunian supports this proposal and, therefore, duly authorizes the Honorable City Mayor Victor Ma Regis N. Sotto to enter into a Memorandum of Understanding with Futran Philippines Inc., to initiate the aforementioned feasibility study;

NOW, THEREFORE, on a motion duly seconded, the Sangguniang Panlungsod resolves, as it hereby resolved, to authorize the Honorable City Mayor, Victor Ma Regis N. Sotto, to enter into a sign a Memorandum of Understanding with Futran Philippines Inc., for the latter to conduct a feasibility study in consideration of a possible "People Mover Project or Mass Transit System" project (involving Monorail, Light Rail, and/or Personal Rapid Transit) that utilizes a "green concept" in the City of Pasig.




RESOLVED, FURTHER, that the copy of the said Memorandum of Understanding shall form an integral part of this Resolution.
