A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. VICTOR MA. REGIS N. SOTTO, TO ALLOCATE FUNDS FOR QUALIFIED BENEFICIARIES OF THE CONTINUING HIGH SCHOOL PROGRAM INCENTIVE (CHIP-IN) OF THE CITY GOVERNMENT OF PASIG FOR THE YEAR 2023.

WHEREAS, Article II, Section 9 of the 1987 Philippine Constitution provides that: "The State shall promote a just and dynamic social order that will ensure the prosperity and independence of the nation and free the people from poverty through policies that provide adequate social services, promote full employment, a rising standard of living and an improved quality of life for all";

WHEREAS, Section 17 of the same article provides that: "The State shall give priority to education, science and technology, arts culture and sports to foster patriotism and nationalism accelerate social progress, and promote total human liberation and development";

WHEREAS, Section 1 of Article XIV of the Philippine Constitution provides that: "The State shall protect and promote the right of all citizens to quality education at all levels, and shall take appropriate steps to make such education accessible to all";

WHEREAS, the City Government of Pasig in its efforts to provide an extensive social services program, intends to address the educational and financial needs of individuals who will be qualified as beneficiaries from various barangays in the City of Pasig thru Continuing High School Program Incentive (CHIP-IN);

NOW, THEREFORE, on motion duly seconded, the City Council resolves, as it is hereby resolved, to authorize the City Mayor, Hon. Victor Ma. Regis N. Sotto, to allocate funds as financial assistance to each and every qualified beneficiaries of the Continuing High School Program Incentive (CHIP-IN) for the year 2023.

RESOLVED, FURTHERMORE, that the budgetary requirement to implement this resolution shall be chargeable against any available funds in the City Treasury subject to existing COA rules and regulations.

RESOLVED, FINALLY, that the Secretary of the Sangguniang Panlungsod furnish all concerned agencies and/or offices with copies of this Resolution, as duly, adopted and approved by the Sangguniang Panlungsod.





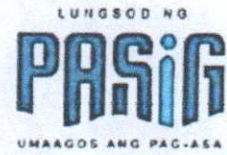

Highlights of the Meeting

It was a highly engaged and participative meeting among the attendees.

Upon the request of the Chairperson, Ms. Ester Yamson, Mr. Rechie Tugawin and Dr. Gilbert Inocencio took turns in giving the following information about the CHIP IN Program: its history, previous implementation and the attendant performance.

In summary, CHIP IN was a long running educational assistance program which was created as a continuing assistance to fill in the expected gap for the graduating batch of the 4Ps Program. During the meeting, prominent among the challenges met were (1) seemingly lack of interest by the target population evidenced by the yearly low acceptance rate (only half of the 7,000 target beneficiaries), (2) inadequate effort in informing the public, (3) unclear role of the schools especially in identifying potential beneficiaries, (4) no clear targeting of priority beneficiaries like those at risk of dropping out, and (5) very stringent requirements for application.

From the discussion, it was clear that there is a need for the CHIP IN Program but a major overhaul of guidelines and policies is called for in order to make it truly matter in the fulfilment of educational objectives of a large number of underserved secondary school students.

In view of the dynamic and comprehensive discussion, more actions were called for beyond the present proposed resolution.

Recommendations

1. Re: the proposed resolution: the meeting was unanimous in their approval to endorse it for to the 11th Sanggunian for second and if so indicated, for third and final reading WITHOUT amendments.
2. With lessons learned from the discussion and with the difficulty of making data-based and confident recommendations at present, the Committee proposed to create an Ad Hoc Committee spearheaded by the Committee on Education the main objective of which is to make a comprehensive and data-based (quantitative and qualitative) evaluation of the school – aged population in order to identify the critical challenges in their education journey and proposed more realistic and adequate assistance to fulfil their secondary learning dreams.






