The joint committee hearing was conducted on January 17, 2023 at the Aquarium, 7/F Pasig Cityhall, to discuss the pertinent provisions of the Proposed Resolution No. 144 Series of 2023 to be entered into by Hon. Mayor Victor Ma. Regis N. Sotto entitled: "A RESOLUTION AUTHORIZING THE CITY GOVERNMENT OF PASIG THROUGH THE HONORABLE CITY MAYOR, VICTOR MA. REGIS N. SOTTO, TO ENTER INTO AND SIGN A CONTRACT ON PRIMARY HEALTHCARE INFORMATION AND CLINICAL SYSTEM WITH THE DBP DATA CENTER INC., AND FOR OTHER PURPOSES".

The Committee Hearing was attended by the following Councilors, Coun. Roderick Mario U. Gonzales, Coun. Quin A. Cruz, Coun. Simon Gerard Tantoco, Coun. Maria Luisa M. De Leon, Coun. Syvel A. Gupilan and Coun. Marion Rosalio M. Martires.

The Committee Hearing was also attended by the following resource persons: Dr. Joseph Panaligan, Mr. Dave Basaca, Dr. Emma Ruth Cuevas, Ms. Rosadiwa Bermedia from DCI, Mr. Bayani Asuncion Jr. and Mr. Wilson F. Chan also from DCI.

During the above-mentioned Committee Hearing the following were discussed:

1. The Resolution will involve an agreement with the DBP Data Center Inc. which will assist the City Government of Pasig to develop a Primary Healthcare Information and Clinical System for the subsequent use of the City's Ten (10) Philhealth Konsulta Accredited Health Facilities and Thirty-Five Barangay Health Centers of Pasig City;
2. Resource persons from DBP Data Center Inc. discussed the benefits of the system provided by DCI and according to them, which was affirmed by the personnel from our CHO, the system was already in place since mid of 2021 and is already utilized, but without any payment yet;
3. Resource persons from our CHO affirmed the benefits of the system provided by DCI in gathering data of patients in Pasig. According to them, through the use of the said system, doctors can provide health services even in remote place;



4. The Committee Hearing also revealed that DBP Data Center Inc. is capable of providing a Primary Healthcare Information and Clinical System designed to conform to the normal operation of any government Primary Care Clinic or Health Center;
5. It was also revealed that DCI has the necessary tools, proven experience, expertise, equipment, manpower, and resources to implement and effectuate the said project;
6. The Councilors present in the hearing inquired on the legality of the said agreement between the City Government of Pasig and DBP Data Center Inc. since it involves sum of money and the City Government is justified in entering into said agreement based on Section 53 of the IRR of R.A. 9184, also known as the Government Procurement Reform Act, particularly Section 53.5 which states that a Procuring Entity may resort to Negotiated Procurement in cases of Agency-to-Agency engagement;

COMMITTEE RECOMMENDATION(S):

It has been the recommendation of the Committee on Health, Nutrition and Sanitation as well as the Committee on Technology, Communication and Energy that Proposed Resolution No. 144-2023 be adopted in whole.

The Committee also recommends that this Proposed Resolution be included in the Agenda for January 19, 2023 Regular Sanggunian Session.






