WHEREAS, Section 455 (b) (1) (V) of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 ("code") provides that the Local Chief Executive has the power to appoint all officials and employees of the City Government:

WHEREAS, Section 454 (d) of the same code provides that, the heads of departments and offices shall be appointed by the City Mayor with the concurrence of the majority of all Sanggunian Panlungsod members, subject to Civil Service laws, rules and regulations;

WHEREAS, Ms. Melanie B. De Mesa applied for the position as City Government Department Head II of the Business Permit and Licensing Department of the City Government of Pasig, and have undergone the regular process through the Human Resource Development Office, subsequently approved her appointment by the City Mayor as appointing authority on January 3, 2023;

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod resolves, as it hereby resolved, to confirm the appointment of Ms. Melanie B. De Mesa as City Government Department Head II of the Business Permit and Licensing Department of the City Government of Pasig, effective January 3,\ 2023.

RESOLVED, FINALLY, that the Secretary of the Sangguniang Panlungsod furnish all concerned agencies and/or offices with copies of this Resolution, as duly, adopted and approved by the Sangguniang Panlungsod.

The Joint Committee Respectfully Reports:

In aid of legislation, the Committee Chair requested the City Human Resource Officer, Ms. Elvira R. Flores to report to the committee how the process of appointment of the said Department Chairpersons will go. Whereas, according to Ms. Flores, the Local Government Code which is considered as the reference of all actions in the LGU Level states that a Department Head position needs confirmation from the Sanggunian Panlungsod. Meanwhile, in the part of the Civil Service Commission Rules where the City HR Department must transmit the appointment paper signed by the Local Chief Executive to the Sangguniang Panlungsod within 7days since its issuance and the Sangguniang Panlungsod should act on the proposed appointment within 15 days.

In terms of the standards, it was duly requested by the committee that Ms. Flores explain to the body the standards and qualification of the said positions. Whereas a person who desires to be a Department Chair/Head must have a bachelor's degree, Career Professional Degree Holder and at least 5 years of supervisory experience with 36 hours of training. But to be specific with the Department Chair on Accounting, one must be a graduate of accountancy and a Certified Public Accountant (CPA) with 5 years of experience. On the other hand, for the City Social Welfare Head position, one must be a licensed social worker.

The committee chairperson yielded the floor to Ms. Melanie de Mesa, OIC for BPLD manifested her gratitude to the 11th council for her proposed confirmation & appointment as the department head. Ms. De Mesa narrated her career in being a public servant where one of the highlights of her career and achievement was when the BPLO Category 2 under her leadership last 2014-2018 earned the most outstanding BPLO office.

The leadership of Ms. Melanie de Mesa in the said department for the number of years was seconded by majority of the members where they manifested their personal encounters with Ms. De Mesa where good accounts according to Councilor Marion Rosalio "MARO" M. Martires like maintaining the Anti-red tape in the BPLD sector was duly enforced by her leadership where it was mentioned that this was an account from his father, former Vice Mayor & City Councilor Yoyong Martires where both of them had a chance to work with one another and the same time, her full support and involvement with the City's desire on having a Ease on Doing Business through the

structural reforms the council legislated and the same time good office relationship as per experience of Councilor Noel "BUBOY" L. Agustin during his time as Office of the

The committee chairpersons, Councilor Mark Gil M. delos Santos & Councilor Simon Gerard R.
