WHEREAS, Section 455 (b) (1) (V) of Republic Act 7160 otherwise known as the Local Government Code of 1991 ("Code") provides that the Local Chief Executive has the power to appoint all officials and employees of the city government;

WHEREAS, pursuant to Section 454 (d) of the same code provides, heads of departments and offices shall be appointed by the city mayor with the concurrence of the majority of all the Sangguniang Panlungsod members, subject to civil service law, rules and regulations;

WHEREAS, Ms. Juvy A. Cuenco applied for the position of the City Government Department Head II of the Accounting Office of the City Government of Pasig, and have undergone the regular process through the Human Resource Development Office, subsequently approved her appointment by the City Mayor as appointing authority on January 3, 2023;

NOW, THEREFORE, on motion duly seconded the Sangguniang Panlungsod resolves, as it hereby resolved, to confirm the appointment of Ms. Juvy A. Cuenco, as City Government Department Head II of the Accounting Office of the City Government of Pasig, effective January 3, 2023.

RESOLVED, FINALLY, that the Secretary of the Sangguniang Panlungsod furnish all concerned agencies and/or offices with copies of this Resolution, as duly, adopted and approved by the Sangguniang Panlungsod.



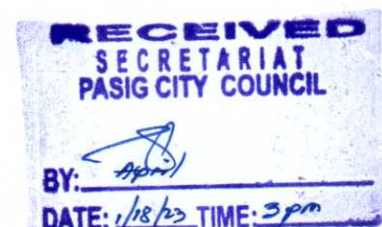

Mr. Presiding Officer and Members of the 11th Sangguniang Panlungsod the Committee on Laws, Rules & Internal Government and Committee on Labor & Employment and Manpower Development respectfully presents & submits the Committee Report on the Committee hearing conducted last January 17, 2023 at the Aquarium, 7th floor Pasig City Hall.

The Joint Committee Respectfully Reports:

In aid of legislation, the Committee Chair requested the City Human Resource Officer, Ms. Elvira R. Flores to report to the committee how the process of appointment of the said Department Chairpersons will go. Whereas, according to Ms. Flores, the Local Government Code which is considered as the reference of all actions in the LGU Level states that a Department Head position needs confirmation from the Sangguniang Panlungsod. Meanwhile, in the part of the Civil Service Commission Rules where the City HR Department must transmit the appointment paper signed by the Local Chief Executive to the Sangguniang Panlungsod within 7 days since its issuance and the Sangguniang Panlungsod should act on the proposed appointment within 15 days.

In terms of the standards, it was duly requested by the committee that Ms. Flores explain to the body the standards and qualification of the said positions. Whereas a person who desires to be a Department Chair/Head must have a bachelor's degree, Career Professional Degree Holder and at least 5 years of supervisory experience with 36 hours of training. But to be specific with the Department Chair on Accounting, one must be a graduate of accountancy and a Certified Public Accountant (CPA) with 5 years of experience. On the other hand, for the City Social Welfare Head position, one must be a licensed social worker.

The floor was then given to Ms. Juvy B. Cuenco, *OIC, Accounting Office* where she narrated her career in the City Government where she started working in 1995 where from that year to the present, she was trusted to be part of both Accounting and BPLD office and vice versa where one of the highlights of her career and leadership, last 2006 the Accounting office was awarded as best incoming generating office in the City. This was attested by Councilor Maro Martires where as the Chairperson for Appropriations & Ways and Means, he is one of the people who always encounter working with the Accounting office and his experience is indeed applaudable where Ms. Cuenco's strict and firm stand on having a clean form of system in the accounting is indeed the reason

why he supports her ad interim appointment. This was seconded by Councilor Quin Cruz where during his experience as Barangay Kagawad, Ms. Cuenco was really strict in terms of all the necessary documents related to her office that anyone who wishes to do things against the virtue of good governance will definitely face consequences or denial of request.

The committee chairpersons, Councilor Mark Gil M. delos Santos & Councilor Simon Gerard R. Tantoco moves the motion to adopt and recommends for approval the proposed resolutions related to the appointment of the said Officer in Charge as Department Heads as their experience and track records do speaks for them and are duly qualified to lead the office to the goal of the City which is to have an inclusive, **transparent and efficient service to the people.**

Summary of Discussion

- The Committee was able to identify the requirements needed to be a Department Head of the Accounting office through the HR Department.
- The Committee was able to identify the credentials of Ms. Juvy A. Cuenco as Accounting Office department head.

Recommendation






