**WHEREAS**, Republic Act No. 6975 otherwise known as the Department of Interior and Local Government Act of 1991 and its Implementing Rules and Regulations mandate the creation of People's Law Enforcement Board (PLEB) in every city;

**WHEREAS**, the PLEB shall have jurisdiction to hear and decide citizen's complaints or cases filed before it against erring officers and members of the Philippine National Police;

**WHEREAS**, Section 43 (b) (1) of same Act states that the PLEB shall have a member from the Sangguniang Panlungsod chosen by their respective Sanggunian;

**WHEREAS**, after deliberation, the Sangguniang Panlungsod of Pasig City, has chosen Honorable Councilor Mark Gil M. Delos Santos as its representative to the PLEB as provided by law;

**NOW, THEREFORE**, on motion duly seconded, the Sangguniang Panlungsod, hereby designates Councilor Mark Gil M. Delos Santos, as representative of Sangguniang Panlungsod of Pasig City to the People's Law Enforcement Board.

**COMMITTEE REPORT**

A Resolution Designating Councilor Mark Gil M. Delos Santos as Representative of Sangguniang Panlungsod of Pasig City to the People's Law Enforcement Board.

After a careful study, the following resolutions were finalized:

1. As presented by Councilor Marion Rosalio M. Martires, the Proposed Resolution No. 143-2023: A Resolution Designating Councilor Mark Gil M. Delos Santos as Representative of Sangguniang Panlungsod of Pasig City to the People's Law Enforcement Board.
2. Councilor Mark Gil M. Delos Santos was the representative of the Sanggunian Panglungsod of Pasig City to the People's Law Enforcement Board. His function is to empower the people against abusive and erring policemen. Also, he has the power to hear and adjudicate all citizen's complaints formally filed with it or refer to it against any uniformed member of the PNP and, if warranted, impose the corresponding penalty.
3. This committee recommends that this report be adopted and passed for a second reading during the next regular session, which will be held on January 26, 2023.
