**A RESOLUTION AUTHORIZING THE CITY GOVERNMENT OF PASIG THROUGH THE HONORABLE CITY MAYOR, VICTOR MA. REGIS N. SOTTO, TO ENTER INTO AND SIGN A MEMORANDUM OF UNDERSTANDING WITH THE UNIVERSAL ROBINA CORPORATION, AND FOR OTHER PURPOSES.**

**WHEREAS**, the GREENWALL PROJECT was conceived in response to the City's aim for a better environment despite the lack of open spaces, with the aim of having the green walls aid in improving air quality in various areas of the City;

**WHEREAS**, among the green walls established is the Bagong Ilog Green Wall, situated along the Pasig-Makati Boundary, C5 Road, Brgy. Bagong Ilog, Pasig City;

**WHEREAS**, Universal Robina Corporation (URC) is supportive of the City's programs on environmental management, and is committed to jointly holding activities that promote environmental conservation as seen in its Tree Planting Activity at Kapasigan Linear Park, Brgy. Kapasigan, Pasig City held on 25 June 2022 by URC employees and personnel from the City Parks and Playground Development Office;

**WHEREAS**, URC has expressed its interest in adopting the Bagong Ilog Green Wall to ensure the continuity and sustainability of the same, especially as it is located near URC's Pasig plant facility;

**WHEREAS**, City Government of Pasig welcomes community participation in the implementation and maintenance of its projects;

**NOW, THEREFORE**, on motion duly seconded, the Sangguniang Panlungsod of hereby resolves, as it hereby resolved to authorize the City Government of Pasig through Honorable City Mayor, Victor Ma. Regis N. Sotto, to enter into and sign a Memorandum of Understanding with the Universal Robina Corporation.

**RESOLVED, FURTHERMORE**, that the Secretary of the Sanggunian Panlungsod furnish all concerned agencies/offices copies of this Resolution, as duly adopted/approved by the Sanggunian Panlungsod.



**PROPOSED RESOLUTION NO. 146-2023:** A Resolution Authorizing The Honorable City Mayor Victor Ma. Regis N. Sotto, To Enter and Sign A Memorandum Of Understanding With Universal Robina Corporation And For Other Purposes.

**DISCUSSIONS & RECOMMENDATIONS FROM COMMITTEE HEARING:**

1. This Memorandum of Understanding, also known as the BAGONG ILOG GREENWALL PROJECT which is a vertical-type garden which will contain ornamental plants such as Picara, will be located in the Bagong Ilog Green Wall (along the Pasig-Makati Boundary) in C5 Road, Barangay Bagong Ilog, Pasig City.

2. URC Representative Ms. Marigie Aragoncillo stated that this is their company's 2<sup>nd</sup> collaboration with Pasig City. On June 25, 2022 they had their first program in support of Pasig CENRO, when they conducted their Tree Planting Activity in the Linear Park in Barangay Kapasigan together with the Parks & Playgrounds division.

3. Mr. Allendri Angeles Department Head of Pasig CENRO and Engr. Emmalyn Sonzo, OIC of Pasig Parks & Playgrounds Development Office both confirmed that this partnership with URC helps address the current need of the City of Pasig for added green spaces as mandated by the Department of Environment and Natural Resources.

4. In this said partnership, the Pasig Parks & Playgrounds Development Office's responsibility is the planting of ornamental plants and in ensuring the availability of manpower and watering materials for the Bagong Ilog Green Wall. URC will adopt the above mentioned responsibilities as well as regularly committing to provide resources in the form of continuous water supply and piping for the said vertical garden from January 2023, up to January 2025.

5. Coun. Reggie Balderram and Coun. Mark Gil Delos Santos, stressed the importance of the support of the City Government Of Pasig with regards to watering of the plants, as well as providing Peace & Order Personnel to regularly inspect the garden.

6. The Committee on Environmental Protection & Human Ecology and the Committee On Parks & Playgrounds recommends s to the adoption of this committee report for 2<sup>nd</sup> reading in the regular council session this January 26, 2023.

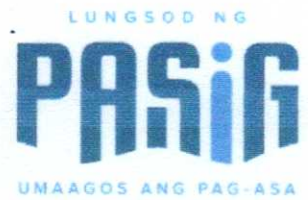
