A RESOLUTION AUTHORIZING THE CITY GOVERNMENT OF PASIG TO GRANT CASH INCENTIVE IN THE AMOUNT OF ONE THOUSAND PESOS (PHP 1,000.00) TO EACH OF THE THREE (3) AWARDEES OF THE BEST PASIG CITY BARANGAY PEACEKEEPING ACTION TEAM MEMBERS AWARDED MONTHLY BY THE EASTERN POLICE DISTRICT-PASIG CITY POLICE STATION, AND TO THE THREE (3) AWARDEES OF THE BEST PERFORMING POLICE OFFICER AND FIVE THOUSAND PESOS (PHP 5,000.00) TO THE BEST PEACEKEEPING ACTION TEAM OR A TOTAL OF (PHP 132,000.00) PER YEAR AND FOR OTHER PURPOSES.

WHEREAS Section 5 of the 1987 Constitution provides that the maintenance of peace and order, protection of life, liberty, and property, and promotion of the general welfare are essential for the enjoyment by all the people of the blessings of democracy;

WHEREAS, Section 458 (xi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that when the finances of the city government allow, provide for additional allowances and other benefits to judges, prosecutors, public elementary and high school teachers, and other national government officials stationed in or assigned to the city;

WHEREAS the Department of Interior and Local Government issued Memorandum Circular No. 2009-145 which enjoins Local Chief Executives to support the Community Mobilization Programs embodied in Philippine National Police (PNP) Letter of Instruction 22/09 "Bayanihan" and PNP Letter of Instruction 40/08 "Damayan";

WHEREAS the said Memorandum Circular also enjoin all Local Chief Executives, as Chairmen of Peace and Order Councils, in relation to their duty to implement Section 16 of the Local Government Code, (the mayors as deputized representatives of the National Police Commission) shall exercise supervision over the Barangay Peace Keeping Action Teams (BPATs) and Police Auxiliary Units (PAUs) and allocate funds for the administrative and operational requirements of BPATs and PAUs

WHEREAS the PNP recognizes the role of the Barangay Tanod, Bantay Bayan, Civilian Volunteer Organization that can be utilized as force multipliers in the fight against criminality, insurgency, terrorism, and as valuable partners in the development of the community;

WHEREAS, the Pasig City Police through Station Order No. 22-016 established a Selection Board to deliberate and evaluate the qualifications and accomplishment of the Pasig City Police Station personnel to include BPATs nominated by the concerned heads of office/Sub-station Commanders;

WHEREAS, the awarding of Best Police Commissioned Officer, Police Non-Commissioned Officers, Non-uniformed Personnel, and Best Barangay Peace Keeping Officers, as well as other civilian/private individual is scheduled every second week of the month during the traditional Monday flag ceremony of the Eastern Police District - Pasig City Police Station to give due recognition for their exemplary and exceptional performances and achievements in ensuring law and order in the City;

WHEREAS, the Pasig City Advisory Council through Joint Resolution No. 04-2022 endorsed to the Honorable City Mayor Victor Ma Regis N. Sotto its recommendation for additional cash incentives be given to each BPAT or civilian/private individual awardee in the amount of One Thousand Pesos (Php 1,000.00) to encourage them to contribute more in the prevention and solution of crime incidents in areas of concern in the City, which the City Government of Pasig deems meritorious in recognition of the awardees' exemplary and achievements in ensuring law and order in the City, to boost the awardees' morale, and as overall support to the City's BPATs and PAUs;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF PASIG, IN REGULAR SESSION DULY ASSEMBLED, to authorize the City Government of Pasig, through the Honorable City Mayor Victor Ma. Regis N. Sotto, to grant cash incentive in the amount of One Thousand Pesos (Php 1,000.00) to each of the three (3) Barangay Peacekeeping Action Team Members awarded monthly by the Eastern Police District - Pasig City Police Station, and to the three (3) awardees of the Best Performing Police Officer and Five Thousand Pesos (Php 5,000.00) to the Best Peacekeeping Action Team or a total of One Hundred Thirty Two Thousand per year.



Mr. Presiding Officer and Members of the 11th Sangguniang Panlungsod the Committee on Peace & Order, Human Rights, Judicial Matters & Anti Drug Abuse respectfully presents & submits he Committee Report on the Committee hearing conducted last January 17, 2023 at the Aquarium, 7th floor Pasig City Hall.

The Committee Respectfully Reports:

Initial discussions pertain to the purpose of the resolution, that is, to promote peace and order in every barangay in Pasig City. IN this regard, the committee proposed to spur the community to action and to contribute to the peace and order by keeping the peace in their own neighborhood/s and to help resolve the drug problem in the community.

PNP Pasig Chief Celerino Sacro informed the committee that the (Pasig - PNP) had been awarding police officers and non-uniformed personnel by giving them certificates of appreciation during their weekly flag raising ceremony.

The committee in coordination with City Budget Officer Martinelli O. Santiago agreed that there should be a maximum of seven (7) awardees per month, consisting of three (3) Police Commissioned Officers, three (3) Barangay Peacekeeping Action Team Members and one (1) Best barangay Peacekeeping Team. These awardees are from a roster carefully selected by a committee established by the Pasig-PNP.

Honorable Syvel A. Gupilan proposed that the committee be composed of officers/employees of Non-Government Organization and or barangay captains to which Chief Sacro agreed and added that their recommendation will require approval and/or confirmation from the entire committee.

The committee then agreed that what is important is that there is a screening committee who will determine who the awardees will be.

Hon. Pao Santiago asked for clarification on the proposed amount of Php 60,000.00, to which the committee added P100,000.00 or a total of P160,000.00.

An amendment was finally proposed to the Title of the Resolution to read as follows:

BE IT RESOLVED BY THE CITY COUNCIL OF PASIG, IN REGULAR SESSION DULY ASSEMBLED, to authorize the City Government of Pasig, through the Honorable City Mayor Victor Ma Regis N. Sotto, to grant cash inventive in the amount of One Thousand Pesos (P1,000.00) to each of the three (3) Barangay Peacekeeping ACTION Team Members awarded monthly by the Eastern Police District - Pasig City Police

Station, and to the three (3) awardees of the Best performing Police Officer and Five Thousand Pesos (P5,000.00) to the Best Peacekeeping Action Team or a total of One hundred Sixty Thousand Pesos (P160,000.00) per year.


Summary of Discussion

- The Committee on Peace & Order, Human Rights, Judicial Matters & Anti Drug Abuse was able to identify that the source of funding for this resolution will be coming from the Office of the City Mayor and the additional beneficiaries is possible as there are available funds.
- The committee was able to identify that the said proposed resolution has a committee that will screen the awardees that will maintain the prestige of the said awards.
- PNP Pasig Chief Celerino Sacro informed the committee that the (Pasig - PNP) had been awarding police officers and non-uniformed personnel by giving them certificates of appreciation during their weekly flag raising ceremony.

Recommendation


- The Committee on Peace & Order, Human Rights, Judicial Matters & Anti Drug Abuse recommends the adoption of the amendments in the proposed Resolution.


