



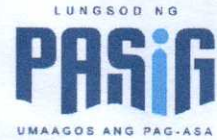

From the resource persons from Ateneo de Manila University it was learned that in compliance with the requirements of CHED, a Memorandum of Agreement is required between the University and Pasig City Government for the latter to permit the proposed 28 Senior Management Engineering students to undertake their off-campus activities in different establishments within the jurisdiction of the city.

On the issue of the joint responsibility of both parties in ensuring the health and safety of the participating students during the conduct of the off-campus activity, Ateneo assures the LGU that there is a separate agreement with the companies or place of the on-the-job training to ensure the same. Any violation on the MOA shall be reported immediately to Ateneo officials who in turn shall take appropriate action immediately.

Realizing that the final MOA document might take some time, Ateneo requests that a temporary certification be issued after the approval of the Sanggunian.
