**WHEREAS**, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that the local government units shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

**WHEREAS**, the Pasig Karate-Do, which consists of fifteen (15) athletes and three (3) coaches for a total of eighteen (18) members, is requesting for financial support from the City Government of Pasig for their participation in the 2023 Karate Pilipinas Sports Federation Inc. Luzon Leg Championship on January 20 to 22, 2023, at Don Narciso Ramos Gymnasium, Lingayen, Pangasinan;

**WHEREAS**, in the 2023 Karate Pilipinas Sports Federation Inc., participants incur costs which include, but is not limited to, entry fees, transportation and food allowance, and accommodation;

**WHEREAS**, it is recommended that the City Government of Pasig provide financial assistance to the Pasig Karate-do in recognition of their contribution to the sports development of the City and to boost their morale as they compete in the 2023 Karate Pilipinas Sports Federation Inc. Luzon Leg Championship;

**COMMITTEE REPORT**

The initial hearing was held on January 30, 2023, at the Session Gallery Hall, 7<sup>th</sup> Floor, Pasig City Hall, in the presence of the majority members of the Committee on Appropriations, Ways, and Means together with City Councilor Honorable Noel Agustin and Ms. Jonalyn Badillo, representative from the Budget Office and Ms. Zamantha Baula, representative from LYDO. Also, with Mr. Charlie D. Lachica, Coach of KarateDo with the Proposed Resolution No. 156-2023: A Resolution Authorizing the City Government of Pasig To Grant Financial Assistance In The Pasig Karate-Do In The Amount Of One Hundred Thirteen Thousand Pesos (Php 113,000) To Help Defray the Cost Of Their Participation In The 2023 Karate Pilipinas Sports Federation Inc. Luzon Leg Championship On January 20 To 22, 2023, At The Don Narciso Ramos Gymnasium, Lingayen, Pangasinan, And For Other Purposes.

2. The tournament was participated by athletes ages 7 to 20 years old. The grant will be use to defray the cost of food, allowance, accommodation and transportation. Furthermore, the said team won 8 golds, 6 silvers and 12 bronzes.
3. This committee recommends that this report be adopted and passed for a second reading during the next regular session, which will be held on February 2, 2023.
