A RESOLUTION COMPLYING WITH THE ORDER OF BRANCH 261 OF THE REGIONAL TRIAL COURT OF PASIG CITY DATED JANUARY 30, 2023 IN RELATION TO THE CASE OF PEOPLE VS GVI-CCL-INQ-22B-00225, R-PSG-22-00885-CR & R-PSG-22-00886-CR.

WHEREAS, the Sangguniang Panlungsod of Pasig City, through the Office of the Secretariat, received an Order dated January 30, 2023 from Branch 261 of RTC-Pasig in relation to the case of *People vs GVI-CCL-INQ-22B-00225, R-PSG-22-00885-CR & R-PSG-22-00886-CR* on February 2, 2023;

WHEREAS, the Honorable Court required the sanggunian to submit a comment by way of a resolution to the *Motion to Release CICL on Recognizance* filed by the accused in the above-mentioned case;

WHEREAS, section 6 (d) of RA No. 10389 or the "Recognizance Act of 2012" states that the sanggunian shall include in its agenda the notice from the court upon receipt and act on the request for comments or opposition to the motion for release on recognizance within ten (10) days from receipt of the notice, that the action of the sanggunian shall be in the form of a resolution, and that the resolution shall be duly approved by the mayor;

WHEREAS, section 6 (d) of RA No. 10389 states that any motion for the adoption of a resolution for the purpose of the said law duly made before the sanggunian shall be considered as an urgent matter and shall take precedence over any other business thereof;

WHEREAS, section 6 (d) of RA No. 10389 also states that the required resolution of the sanggunian shall include a list of recommended organizations from whose members the court may appoint a custodian;

WHEREAS, the accused in the above-mentioned case is a minor;

WHEREAS, the identify of a child in conflict with the law together with all records and proceedings of the case of said child are strictly confidential pursuant to Section 43 of R.A. No. 9344 or the "Juvenile Justice and Welfare Act of 2006";

WHEREAS, the sanggunian does not have factual basis to concur nor oppose the *Motion to Release CICL on Recognizance* filed by the minor accused due to the confidentiality rule under R.A. No. 9344.

NOW THEREFORE, be it RESOLVED, as it is hereby RESOLVED by the City Council of Pasig, as hereby resolved in Regular Session duly assembled, the following:
