

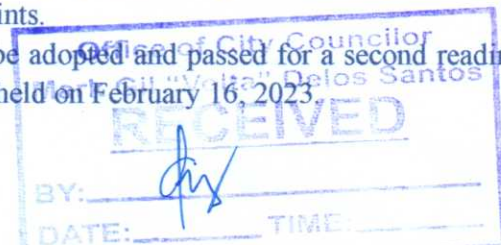


COMMITTEE REPORT

The initial hearing was held on February 13, 2023 at the Session Gallery Hall, 7th Floor, Pasig City Hall in the presence of the majority members of the Committee on Appropriations, Ways and Means, together with Mr. Patrick Acupan, representative from Action for Economic Reforms Inc. with the Proposed Resolution No. 166-2023: A Resolution Authorizing The City Government Of Pasig, Through The Honorable City Mayor, Victor Ma. Regis N. Sotto To Enter Into And Sign A Deed Of Donation And Acceptance With Action For Economic Reforms Inc., And For Other Purposes referred to the Committee on Appropriations, Ways and Means during the Regular Session held on February 9, 2023.

After a careful study, the following resolutions were finalized:

1. As presented by Councilor Marion Rosalio Martires, the Proposed Resolution No. 166-2023: A Resolution Authorizing The City Government Of Pasig, Through The Honorable City Mayor, Victor Ma. Regis N. Sotto To Enter Into And Sign A Deed Of Donation And Acceptance With Action For Economic Reforms Inc., And For Other Purposes.
2. Action for Economic Reforms Inc. (AER) is to donate 1 Dell IN 3501 Intel Core i7 laptop, 1 HP DeskJet Ink Advantage 6475 printer, 1 8GB Memory DDR4 3200, Backpack bag, and Wireless Mouse.
3. AER has been partnered with Pasig for 2 years with a goal to help enable data-driven decision making in policies. AER has worked with Ugnayan sa Pasig in revolutionizing its processes to an updated, online-based system. AER chooses to donate to Pasig since the city is a good champion of Freedom of Information and Transparency, and there is an opportunity for Pasig to be a model for other LGUs in practicing transparency.
4. Councilor Mark Gil Delos Santos asks what other programs are there between Pasig and AER, Mr. Acupan answers that it has also partnered with MIS, Office of the City Mayor; hosted workshops, participated in policy discussions and also passed a resolution for a Technical Working Group on Freedom of Information.
5. Councilor Paulo Santiago asks how the communication with the constituents can be strengthened, Mr. Acupan explains that they have a close relationship with their consultants in Pasig, naming Ms. Malou Mangahas, and in Ugnayan sa Pasig – whom they can easily message for legal questions or to raise complaints.
6. This committee recommends that this report be adopted and passed for a second reading during the next regular session, which will be held on February 16, 2023.
